**WITHDRAWAL ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, State Council of Educational Research & Training, Vill.-Patna City, PO.-Mahendru, Street-Ashok Rajpath, City-Patna, Dist-Patna, Bihar-800006 was granted recognition for conducting D.El.Ed-ODL. programme of two year duration with an annual intake of 500 students vide order No. ERC/7-130.6(i).7/2012/10485 dated 28.02.2012 from the academic session 2012-2013.

2. AND WHEREAS, the Show cause notice under section 17 (1) of NCTE Act, 1993 was issued on 05.08.2022 as per decision of 306<sup>th</sup> meeting of ERC held on 12<sup>th</sup> to 13<sup>th</sup> July, 2022 to the all institutions which have not filed PAR on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014 and also clause 7 (14)(i) of NCTE, Regulations, 2014 which is related to uploading information on the website.

3. AND WHEREAS, the institution has not submitted reply of show cause notice dated 05.08.2022. The matter was again placed before 311<sup>th</sup> meeting of ERC held on 11<sup>th</sup> Oct, 2022. The Committee decided that Final Show Cause Notice be issued before withdrawal of recognition under Section 17 of the NCTE Act, 1993 to submit reply within 15 days from the date of issue of Final Show Cause Notice. As per decision of ERC-NCTE, Final SCN was issued to the applicant institution on 28.10.2022.

4. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in 316<sup>th</sup> (virtual) meeting held on 20<sup>th</sup> December, 2022 by ERC and the Committee observed that the institution has not submitted the reply of First Show Cause Notice dated 05.08.2022 and Final Show Cause Notice dated 28.10.2022 issued to it for non-submission of Performance Appraisal Report (PAR) for the academic session 2020-21. Hence, Committee decided that the recognition for D.El.Ed.-ODL Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.

5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. State Council of Educational Research & Training, Vill.-Patna City, PO.-Mahendru, Street-Ashok Rajpath, City-Patna, Dist-Patna, Bihar-800006 vide order No. ERC/7-130.6(i).7/2012/10485 dated 28.02.2012 from the academic session 2012-2013. For running D.El.Ed.-ODL programme for 500 students (ten units) is hereby withdrawn with effect from the end of academic session next following the date of communication of withdrawal order.
