WHEREAS, in terms of Section 14/15(3)(a) of the NCTE Act, 1993, recognition was granted to **Nand Kumar Hari Roy B.Ed. College, Plot No.63, Street No-Bhergawa, Vill/PO-Bhergawa, Tehsil/Taluka-Dhanarua, Town/City-Patna, Dist- Patna, Bihar-804451** for conducting B.Ed. programme of two year duration with an annual intake of 100 vide Order No. F.No.ER239.6.22/ERCAPP3420/B.Ed./2017/52774 dated 02.05.2017 from the academic session 2017-2018, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, institution has submitted representation dated 30.10.2023 along with relevant documents for changing its affiliating university from **Magadh University, Bodh Gaya, Bihar to SNTD Women's, University, Mumbai, Maharashtra.**

In view of the above, the Committee decided to accord permission to change the affiliating university from the erstwhile university, namely the "Magadh University, Bodh Gaya, Bihar" to "SNTD Women's, University, Mumbai, Maharashtra from the Academic Session 2023-24 onwards" for B.Ed. programme. Orders be issued accordingly".

4. **NOW THEREFORE**, in terms of decision of ERC, permission is hereby granted **Nand Kumar Hari Roy B.Ed. College, Plot No.63, Street No-Bhergawa, Vill/PO- Bhergawa, Tehsil/Taluka-Dhanarua, Town/City-Patna, Dist- Patna, Bihar-804451** to change its affiliating body from **"Magadh University, Bodh Gaya, Bihar to SNTD Women's, University, Mumbai, Maharashtra"** with immediate effect.
