ORDER

WHEREAS, Yogoda Satsanga Palpara Mahavidyalaya, P.O.- Palpara, P.S.-Pataspur, Dist.-Purba Medinipur, West Bengal-721458 (Code No. APE00559) was granted recognition for B.Ed. course with an annual intake of 100 vide ERC Order vide No. 6188 dated 07.02.2007, followed by revised Order vide No. 32354 dated 29.05.2015 with an annual intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, the ERC in its 284^{th} meeting held on $17^{\text{th}} - 18^{\text{th}}$ September, 2020 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 from the academic session 2020-2021 Vide ERC order No. ER-284.10/APE00559/B.Ed./2020/63080 dated 29.09.2020 to the Institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC order dated 29.09.2019. The Appellate Authority vide order No.F.89-270/E-171025/2020/Appeal/3rd Mtg.-2021/20th January, 2021/97371 dated 11.02.2021 remanded back the case to ERC with a direction to consider the Fire safety Certificate dt.19.11.2020 to be sent them by the applicant and take further necessary action as per the NCTE Regulation, 2014.The appellant is directed to forward the Fire Safety Certificate within 15days of receipt of orders on the appeal.

4. **AND WHEREAS**, the institution submitted reply vide letter dated 12.02.2021 received on 16.02.2021. The Original file of the institution along with other related documents, NCTE Act, 1993. Regulations and guidelines issued by NCTE from time to time and appeal order dated 11.02.2021, were carefully considered by ERC in its 290th Meeting (Part-1) held on 3rd March-2021 and decided as under:-

"Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued."

6. NOW, THEREFORE, recognition withdrawn vide order No. ER-284.10 / APE00559 / B.Ed. / 2020/63080 dated 29.09.2020. to the institution viz. Yogoda Satsanga Palpara Mahavidyalaya, P.O.- Palpara, P.S.- Pataspur, Dist.-Purba Medinipur, West Bengal-721458 for B.Ed. course is hereby restored recognition with an annual intrake of 100 students (two basic units).
