ORDER

WHEREAS, Siddhartha Teacher's Training College, Vill/Po—Jehanabad, Dist—Jehanabad, Bihar—804408 was granted recognition for B.Ed. Course with an annual intake of 100 vide Order No.1047 dated 05.08.2009 from the academic session 2009-2010, followed by revised recognition order dt.30.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS**, as per decision of the ERC taken in its 275th meeting held on 27th July, 2019 the recognition to B.Ed. course was withdrawn from the academic session 2020-2021. Accordingly, withdrawal order issued to the institution vide No.61491 dt.02.09.2019.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order of ERC. The appellate authority vide order No.89-394/E-137067/2019 Appeal/20th Mtg.-2020/4th September, 2020/94740 dt.02.11.2020 decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal order, copy of the list of faculty approved by affiliating university and the mark sheet of Sh. Upendra Kumar. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the ERC in its 286th meeting held on 25th–26th November, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 02.11.2020 and Committee decided to issue a Show Cause Notice to the institution. Accordingly, Show Cause Notice was issued to the institution on dt.09.12.2020.
- 5. **AND WHEREAS,** in response of the Show Cause Notice institution submitted its representation dated 11.02.2021 received on 12.02.2021. The ERC in its 289th meeting held on 15th February, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to Show Cause Notice and decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued to the institution on dt.24.02.2021.
- 6. AND WHEREAS, in response of the Show Cause Notice institution submitted its representation dated 26.02.2021 received on 27.02.2021. The ERC in its 290th meeting held on 03rd March, 2021 considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to final show cause notice, were carefully considered by ERC and the Committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

7. **NOW THEREFORE**, recognition withdrawn vide order dated 02.09.2019 to the institution viz. Siddhartha Teacher's Training College, Vill/Po – Jehanabad, Dist – Jehanabad, Bihar – 804408 for **B.Ed.** course is hereby restored with total annual intake of 100 (Two units).
