ORDER

Whereas, the Institute for Education, Plot No.- 1757, 1758, 1762, 1787, 1788, Vill.- Bijay, P.O.-Seraikela, Dist.- Paschim Singhbhum, Jharkhand- 833219 (Code No. ERCAPP1405) was granted recognition for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2014-2015 vide ERC's order no. ERC/7-170.6.47/NCTE/B.Ed./2014/24386 dt. 03.03.2014.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide ERC's order no. ERC/NCTE/ERCAPP1405/B.Ed.(Revised Order)/2015/32079 dt. 25.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 279^{th} meeting held $14^{th} 16^{th}$ July, 2020 considered the matter and decided as follows:-
 - (i) Teaching faculty mentioned at Sl. No. 1, 3, 5 & 15 are having less than required 55% marks in P.G. degree.
 - (ii) Built up area 1s less than the requirement of 4000 Sq. Mts. for running 02 units of B.Ed. and 02 units of D.El.Ed. course as per NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21."

4. And whereas, the ERC in its 280th meeting held on 29th February & 1st March, 2020 reviewed the matter and decided as follows:

"Keeping in view of the total built up area, which is not sufficient to run 02 units of B.Ed. and 02 units of D.El.Ed. course as per NCTE Regulation, 2014.

Hence, the committee decided to reduce 01 unit (50 intake) from 100 intake from the next academic session i.e. 2020-21."

Accordingly, recognition granted to the institution for conducting B.Ed. Course was reduced 01 unit (50 intake) from 100 (two units), thus, the total annual intake of the institution remained 50 (One basic unit) vide order no. ERC-280.3/ERCAPP1405/B.Ed./2020/62561 dt. 03.03.2020 from the academic session 2020-2021.

5. And whereas, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order dated 26.02.2020 and the Appellate Authority vide order no. 89-92/E-157969/2020 Appeal/14th Mtg.- 2020/28th July, 2020/93152 dt. 15.09.2020 remanded back the case to the ERC for revisiting the matter by taking into consideration the two Building Completion Certificate and the improved mark-sheet of faculty at serial no.-15.

- 6. And whereas, the ERC in its 286th meeting held on 25th & 27th November, 2020 considered the appeal order dated 15.09.2020, considered and decided to issue show cause notice and the same was issued on 04.12.2020 to the institution on the following grounds:-
 - (i) MNREGA Engineer is not authorized to sign on the Building Completion Certificate (BCC).

Hence, show cause notice under section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

7. And whereas, the institution submitted a reply dt. 29.12.2020 received in this office on 31.12.2020. The ERC in its 289th meeting held on 15th February, 2021 considered the reply of the institution and decided to issue a letter to the Block Development Officer, Seraikela and the same was issued on 18.02.2021 on the following grounds:-

"In response to show cause notice dated 04.12.2020, the institution vide its letter dated 29.12.2020 has submitted its reply in support of issue of BCC (building completion certificate) by the MNREGA Engineer.

(i) Information submitted by the institution needs to be verified from the concerned Block Development Officer of the area under which the institution is located.

The Committee decided that a letter be issued to the Block Development Officer, Saraikela to confirm the eligibility of MNREGA Engineer, Saraikela for issuance of Building Completion Certificate (BCC). The BDO may be requested to submit the reply within 30 days from the date of issue of letter."

8. And whereas, the BDO of Seraikela has submitted a reply dt. 01.03.2021 and the ERC in its 290th meeting held on 3rd March, 2021 considered the reply submitted by the BDO of Seraikela alongwith original regulatory file & other related documents, NCTE Act, 1993, Regulations & Guidelines issued by NCTE from time to time and decided as under:-

"Restoration of recognition order for B.Ed. course to be issued for another one unit (50 intake). Hence, the total 02 units (100 intake) is permitted."

- 9. Now therefore, an intake of 50 seats (01 unit) reduced vide order no. F.No.ERC-280.3/ERCAPP1405/B.Ed./2020/6256 dt. 03.03.2020, is restored herewith, thus making the existing intake of B.Ed. course to 100 seats (02 units), from session 2021-22 to the Institute for Education, Plot No.- 1757, 1758, 1762, 1787, 1788, Vill.- Bijay, P.O.- Seraikela, Dist.- Paschim Singhbhum, Jharkhand- 833219.
- 10. The ERC order no. F.No.ERC-280.3/ERCAPP1405/B.Ed./2020/6256 dt. 03.03.2020 will be treated a cancelled from the date of issue of this order.
- 11. The terms and conditions of the order No. F. ERC/NCTE/ERCAPP1405/B.Ed.(Revised Order)/2015/32079 dt. 25.05.2015 issued to the institution shall remain same.
