ORDER

WHEREAS, Maulana Azad National Urdu University, College of Teacher Education, Danishgahe Islamia High School, Muslim Education Society (Trust), School Lane, Hutton Road, Asansol, West Bengal-713301 (Code No. Nil) was granted recognition for B.Ed. in (Urdu) with an annual intake of 100 from the academic session 2014-2015 vide ERC Order vide No. 24062 dated 20.02.2014, followed by revised Order issued vide No. 32549 dated 30.05.2015 with an annual intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS,** the ERC in its 284th meeting held on 17th 18th September, 2020 considered the matter and as decided, recognition granted to B.Ed.(Urdu) course was withdrawn u/s 17(1) of NCTE Act, 1993 from the academic session 2021-2022 Vide ERC order No. ER-284.19(Code Nil)/B.Ed./2020/63124 dated 05.10.2020 to the Institution.
- 3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC order dated 05.10.2020. The Appellate Authority vide order No.F.89-258/E-170368/2020 Appeal/31st Mtg.-2021/20th January, 2021/97379 dated 11.02.2021 remanded back the case to ERC for revisiting the matter.
- 4. **AND WHEREAS**, the institution submitted representation vide letter dated 05.01.2021 received on 08.01.2021. The ERC in its 288th meeting held on 29th January, 2021 considered the matter and as decided, show cause notice u/s 17 of NCTE Act, 1993 was issued to the institution dated 05.02.2021 on the following grounds:
 - (i) Copies of testimonial & individual affidavit relating to newly appointed faculty member are to be submitted.
- 5. **AND WHEREAS**, the institution submitted reply vide letter dated 22.02.2021 received on 27.02.2021. The original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice, were carefully considered by ERC in its 290th Meeting (Part-1) held on 3rd March-2021 and decided as under:-

"Restoration of recognition order of B.Ed.(Urdu) course with an annual intake of 100 (two units) be issued."
