WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Govt. Normal Training School, Lower Chandmari, West Garo Hill, Tura, Meghalaya-794002 for conducing NTTC programme of two year duration with an annual intake of 40 students vide order No.2799(12) dated 11.02.1997 from the academic session 1997-1998.

- 2. AND WHEREAS, the Show cause notice under section 17 (1) of NCTE Act, 1993 was issued on 04.08.2022 as per decision of 306th meeting of ERC held on 12th to 13th July, 2022 to the all institutions which have not filed PAR on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014 and also clause 7 (14)(i) of NCTE, Regulations, 2014 which is related to uploading information on the website.
- 3. AND WHEREAS, the institution has not submitted reply of show cause notice dated 04.08.2022. The matter was again placed before 311th meeting of ERC held on 11th Oct, 2022. The Committee decided that Final Show Cause Notice be issued before withdrawal of recognition under Section 17 of the NCTE Act, 1993 to submit reply within 15 days from the date of issue of Final Show Cause Notice. As per decision of ERC-NCTE, Final SCN was issued to the applicant institution on 28.10.2022.
- 4. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in316th (virtual) meeting held on 20thDecember, 2022 by ERC and the Committee observed that the institution has not submitted the reply of First Show Cause Notice dated 04.08.2022 and Final Show Cause Notice dated 28.10.2022 issued to it for non-submission of Performance Appraisal Report (PAR) for the academic session 2020-21.Hence, Committee decided that the recognition for D.El.Ed. programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.
- 5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Govt. Normal Training School, Lower Chandmari, West Garo Hill, Tura, Meghalaya-794002 vide order No. 2799(12) dated 11.02.1997 from the academic session 1997-1998 for running NTTC) programme for 40 students is hereby withdrawn with effect from the end of academic session next following the date of communication of withdrawal order.
