WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Sai College of Education, Plot No.- 383/384, Street No.-Earki, Vill.-Earki, P.O./Tehsil/Taluka - Jehanabad, Town/City-Jehanabad, Dist.-Jehanabad, Bihar-804408 for conducting B.Ed. programme of one year duration with an annual intake of 100 vide order No.ER-187.6.2/ERCAPP1489/B.Ed./2015/31664 dated 15.05.2015, as per NCTE Regulations, 2014 and addl. Intake of 50 (Existing 100 +Addl.50= 150) thus making the sum total intake of 150 (Three Basic Units) from the academic session 2016-2017 vide ERC order No. F.No.ER-213.6.(i).63/ERCAPP4069/B.Ed.(Addl. Intake) /2016 /46026 dated 02.05.2016, followed by addl intake of 50 (Existing 150 + Addl.50 = 200) thus making the sum total intake of 200 (Four Basic Units of 50 students each)from the academic session 2018-19 vide order No. F.No.ER-249.2.3/ ERCAPP4069 /B.Ed./ 2018/ B.Ed. /2018/ 56057 dated 15.02.2018 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, a letter No.NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284thmeeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the show cause notice to the institutions which have been recognized without NET qualified teachers. Accordingly, first SCN was issued to the institution on dated 28.09.2020.
- **3. AND WHEREAS,** the matter was placed before ERC in its 303rd (Virtual) meeting held on 24thMarch, 2022 and the committee decided to issue final show cause notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs).Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022.The reply of the institution was received in ERC on 26.04.2022 & 07.06.2022.
- **4. AND WHEREAS,** the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 316th (virtual) meeting held on 20thDecember, 2022 and the Committee observed that:

"The institution has submitted its reply in response to the Final Show Cause Notice dated 09.04.2022 which is still deficient on the following grounds:

- The institution has not submitted latest list of teaching faculty duly approved by the affiliating university along with affidavit, testimonials, service certificate, marks card etc
- The website of the institution is not operational.
- From the Performance Appraisal Report (PAR) for the academic session 2021-21, it isobserved that the institution has not updated its website as per NCTE Regulations, 2014.

Hence, Committee decided that the recognition for B.Ed. & B.Ed. (Additional) Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

- 5. NOWTHEREFORE, in terms of above decision of ERC, the recognition granted to Sai College of Education, Plot No.- 383/384, Street No.- Earki, Vill.-Earki, P.O./Tehsil/Taluka-Jehanabad, Town/City Jehanabad, Dist.-Jehanabad, Bihar-804408 vide order No. F.No. ER-249.2.3/ERCAPP4069/B.Ed./2018/B.Ed. /2018/ 56057 dated 15.02.2018 for running B.Ed. programme for basic and additional units is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.
- 6. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
