**ORDER**

WHEREAS, Kabi Samrat Upendra Bhanj College of Teacher Education, Bhanjanagar, Plot No.- 321-1, Street No.- Ialsingh, Vill - Bhanjanagar, PO - Bhanjanagar, Tehsil-Taluka - Bhanjanagar, Town-City - Bhanjanagar, Dist - Ganjam, Odisha - 761126 (Code No. ORS/E-2/96 & ERCAPP1862) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 24233 dated 24/02/2014, followed by revised order vide No.32697 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 271<sup>st</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the ERC in its 274<sup>th</sup> Meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered the matter along with the reply dated 22.04.2019 & 29.05.2019 submitted by the institution in response to Show Cause Notice and observed as under:

1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following grounds:-

- Faculty list comprises 1+5 instead of 1+15 for running two units (100 intake) of B.Ed. course. Faculties at sl. No.2 & 3 are on part-time, not accepted.
- The submitted faculty is not as per NCTE Regulations, 2014.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
