ORDER

WHEREAS, in terms of Section 14(3)(a) of the NCTE Act, 1993, the recognition was granted to Barnagar B.Ed. College, Sorbhog, Barpeta, Assam-781317 for conducting B.Ed. programme of one year duration with an annual intake of **50** students *vide* Order No. ERC/7-19/2001/1659 dated 15.06.2001 from the academic session 2001-2002, followed by revised recognition order for B.Ed. programme of two years duration with an annual intake of 50 students (One basic unit) from the academic session 2015-2016 *vide* Order ERC/NCTE/AS-S/N-6/2000/B.Ed. (Revised Order) 2015/31924 dated 23.05.2015, as per NCTE Regulations, 2014.

- 2. AND WHEREAS, recognition of the institution was withdrawn *vide* Order No. ERC-1313.49/AS-S/N-6/2000/B.Ed./2022/66920 dated 24.11.2022.
- 3. AND WHEREAS, the Appellate Authority vide Order No. F.No.89-61/E-299265/2023 Appeal/4th Meeting, 2023 APPLERC202314536/117886 dated 12.04.2023, decided as under:
 - "...After perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal to the ERC in light of the aforesaid Hon'ble High Court order dated 13.03.2023 which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2021, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verify the submitted documents from the concerned issuing authority."
- **4. AND WHEREAS**, representation dated 24.04.2023 received in ERC office on dated 02.05.2023 was considered by the ERC in its 326th (Virtual) meeting of the ERC held on 23.05.2023 and the committee decided as under:-

"The original file of the institution alongwith Appeal Order No. F.No.89-61/E-299265/2023 Appeal/4th Meeting, 2023 APPLERC202314536/117886 dated 12.04.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

- The Committee noted that the withdrawal order 24.11.2022 has already been set aside by the Appellate Authority vide its Order dated 12.04.2023 and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is hereby restored. Order be issued accordingly."
- 9. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Barnagar B.Ed. College, Sorbhog, Barpeta, Assam-781317 vide Order ERC/NCTE/AS-S/N-6/ 2000/B.Ed. (Revised Order) 2015/31924 dated 23.05.2015 for an annual intake of One basic unit of 50 students each is hereby restored subject to fulfillment of the condition as per NCTE Regulations, 2014 until a fresh withdrawal order is issued by ERC.
