- 2. AND WHERAS, the ERC in its 279^{th} meeting held on $14^{th} 16^{th}$ February, 2020, considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 62397 dated 26/02/2020 from the academic session 2020-2021 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 26.02.2020. The Appellate Authority vide order No. 89-62/E-155591/2020 Appeal/12th Mtg.-2020/24th July, 2020 dated 15/09/2020. The Appeal Committee decided that appellant is required to resubmit the original FDRs in the office of ERC within 15 days of the issue of appeal order. The impugned order of withdrawal dated 26/02/2020 is set aside.
- 4. AND WHEREAS, the institution submitted reply dated 16.09.2020 received in this office on 16.09.2020. The ERC in its 284th meeting held on 17th & 18th September, 2020 and the committee decided as under:

NOW, THEREFORE, recognition withdrawn vide order dated 26/02/2020, Ratulia Secondary Teachers Training Institute, Panskura Vidyasagar Social Welfare Society Building, Vill.- Kanakpur, P.O.- Naranda, Dist.- Purba Medinipur, West Bengal 721139 (Code No. APE00573) for B.Ed. course is hereby restored.
