ORDER

WHEREAS, Gorakh Singh College Maharajganj Siwan, At-Maharajganj, Dist-Siwan, Bihar-841238 (APE00751) was granted recognition for B.Ed. course with an intake of 100 (Two basic Units) from the academic session 2008-2009 vide ERC order No.11049(4) dated 30.05.2008, followed by revised order vide No.32525 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014:

- 2. AND WHEREAS, the ERC in its 274^{th} meeting held on $15^{th} 16^{th}$ July, 2019 considered the matter of the institution and decided to withdraw recognition under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021 on the following grounds:
 - i. Faculty list comprises 1+14, which is less than required 1+15 as per NCTE Regulations, 2014.
 - ii. Faculties at sl. No. 8 to 14 of the list appointed after Gazette Notification dated 09.06.2017, who do not possess requisite qualification.
- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order of ERC and the appellate authority vide its order No.89-375/E-136403/2019 Appeal/ 5th Mtg. -2020/4th February, 2020/90091 dt.11.03.2020 remanded back the case to ERC for revisiting the matter. Appellant institution should submit to ERC within 15 days of the issue of appeal order, original of the faculty list approved by affiliating university with evidence of qualifications of the faculty and letter of university granting approval.
- 4. AND WHEREAS, on the direction of Appellate Authority, institution submitted its reply vide letter dt.17.03.2020 received on 08.05.2020. The ERC in its 283rd meeting held on 24th & 25th August, 2020 considered the matter and as per decision of the Committee a Show Cause Notice issued to the institution on 11.09.2020.
- 5. AND WHEREAS, in response to the Show Cause Notice institution submitted its reply dt.08.09.2020 received on 14.09.2020. The ERC in its 284^{th} meeting held on $17^{th} 18^{th}$ September, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and committee decided as under:-

"Restoration of Recognition Order of B.Ed. course to be issued".

6. NOW THEREFORE, recognition withdrawn vide order No.61422 dated 28.08.2019 to the institution viz. Gorakh Singh College Maharajganj Siwan, At-Maharajganj, Dist-Siwan, Bihar-841238 (APE00751) for B.Ed. course is hereby restored.
