ORDER

WHEREAS, Dr. Jagannath Mishra Mahavidyalay, Vill-Chandwara, PO-Ramna, City-Muzaffarpur, Dist-Muzaffarpur, Bihar-842001 (APE00978) was granted recognition for B.Ed. course with an intake of 100 (Two basic Units) from the academic session 2009-2010 vide ERC order No.1363 dated 31.08.2009, followed by revised order vide No.32329 dated 28.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 272nd meeting held on 30^{th-} 31st May & 01st June 2019 considered the matter and decided to withdraw recognition of the institution from the academic session 2019-2020 on the following grounds:
 - i. Show Cause Notice u/s 17(1) were issued on 20.04.2018, 26.11.2018 & 17.01.2019.
 - ii. No reply received from the institution in response to SCN dated 17.01.2019 regarding submission of faculty list approved by the concerned affiliating body.
 - iii. Despite repeated SCN for compliance, the said institution has failed to fulfil the Norms as per NCTE Regulations, 2014.
- 3. AND WHEREAS, the order of withdrawal was not issued to the institution and the matter was re-considered by ERC in its 273rd (Emergent) meeting held on 14th June'2019 through online mode and observed that in terms of Section 17(1) of NCTE Act, 1993, order withdrawing or refusing recognition passed by the Regional Committee shall come into force only with effect from the end of the academic session next following the date of communication of such order. In the instant cases, all formalizies and process of counselling for admission of students have been completed by the affiliating/examining bodies for the next academic session 2019-2020.

In view of the above, the Committee decided as under:-

Recognition to B.Ed. course be withdrawn from the academic session 2020-2021 instead of 2019-2020 in all respect and orders be issued accordingly.

- 4. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the refusal order of ERC and the appellate authority vide order No.89-21/E-150843/2020 Appeal/8th Mtg. 2020/ 27th February, 2020/91462 dt.15.07.2020 remanded back the case to the ERC with a direction to consider the approved list, to be submitted by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC, the approved faculty list and within 15 days of receipt of orders on the appeal.
- 5. AND WHEREAS, on the direction of Appellate Authority, institution submitted reply dt.14.08.2020 received on 29.08.2020. The ERC in its 283rd meeting held on 24th & 25th August, 2020 considered the matter and as per decision of the Committee a Show Cause Notice issued to the institution on 11.09.2020 on the following ground:

- i. Details of certified copy of marks card, experience certificate and appointment order of Principal and Assistant Professors (15) along with all testimonials as per the list approved by the affiliating University to be submitted.
- 6. AND WHEREAS, in response to the Show Cause Notice institution submitted its reply dt.31.07.2020 & 03.09.2020 received on 27.08.2020 & 07.09.2020 respectively on the basis of uploaded proceedings of 283rd ERC meeting on ERC website. The ERC in its 284th meeting held on 17th–18th September, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and committee decided as under:-

"Restoration of Recognition Order of B.Ed. course to be issued".

- 7. NOW THEREFORE, recognition withdrawn vide order No.60921 dated 27.06.2019 to the institution viz. Dr. Jagannath Mishra Mahavidyalay, Vill-Chandwara, PO-Ramna, City-Muzaffarpur, Dist-Muzaffarpur, Bihar-842001 (APE00978) for B.Ed. course is hereby restored.
- 8. The terms and conditions of the Order No. F. ERC/ NCTE/ APE00978/ B.Ed. (Revised Order)/ 2015/ 32329 Date:-28.05.2015 issued to the institution shall remain same.
