Whereas, the institution Prof Qoumrul Hoque School of Education University of Science and Technology, Plot No.- 52, Street No.-101, Vill.- Baridua, P.O.- Killing Centre, Tehsil/Taluka- Ri Bhoi, Town/City- Techno City, Dist.- Ri Bhoi, Meghalaya-793101 (Code No. ERCAPP45/2012) was granted recognition for B.Ed. course of one year duration with an annual intake of 100 students vide ERC's order no. ERC/7-170.6.5/NCTE/B.Ed./2014/24375 dt 03.03.2014 from the academic session 2014-2015.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide ERC's order no. ERC/NCTE/ERCAPP45/2012/B.Ed.(Revised Order)/2015/31778 dt. 20.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 274th meeting held 15th 16th July, 2019 considered the matter and decided as follows:-

"1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 18.05.2019 on the following grounds:-

- a. Approved faculty list by the concerned affiliating body along with requisite documents.
- b. Approved building plan by the concerned competent Govt. Engineer/Authority.
- c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- e. Confirmation on website updates of the institutions with all details along with affidavit.

No reply received and the stipulated time period has already been over.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

Accordingly, withdrawal order u/s 17(1) issued vide order no. F.No.ER-274.14.83/ (ERCAPP45/2012)/B.Ed./2019/61151 dt. 05.08.2019 from the academic session 2020-2021 to the institution.

- 4. And whereas, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 05.08.2019. The Appellate Authority vide its order no.89-08/E-147922/2020 Appeal/7th Mtg.-2020/25th February, 2020/90409 dt. 19.03.2020 remanded back the case to ERC for revisiting the matter after the appellant resubmits complete and comprehensive reply to S.C.N.
- 5. And whereas, the institution submitted reply vide letter dated 02.04.2020 received in ERC, NCTE on 03.06.2020. The ERC in its 282nd meeting held on 08th 09th July, 2020 considered the matter and decided to issue 1st Show Cause Notice and the same was issued on 16.07.2020 to the institution on the following grounds:-
 - (i) List of teaching faculty duly approved by the Registrar of the concerned affiliating body in the NCTE prescribed proforma to be submitted.
 - (ii) Blue Print of the Building Plan (BP) mentioning the details of Plot No./khasra No., total land area & total built up area etc. duly approved by the Govt. Engineer to be submitted.
 - (iii) Prof. Jonali Chetia is not eligible as the experience mentioned in the list of Teaching faculty is 3.7 years, which is not permissible as per Appendix-4 of Regulation-2014/ Norms & Standards.
- 6. And whereas, the institution submitted reply vide letter dated 14.09.2020 received in ERC, NCTE on 16.09.2020. The ERC in its 284th Meeting held on 17th 18th September, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and decided as under:-

Restoration of Recognition Order of B.Ed. course to be issued.

- 7. Now therefore, recognition withdrawn vide order dated 26.08.2019 to the institution viz. Prof Qoumrul Hoque School of Education University of Science and Technology, Plot No.- 52, Street No.-101, Vill.- Baridua, P.O.- Killing Centre, Tehsil/Taluka- Ri Bhoi, Town/City- Techno City, Dist.- Ri Bhoi, Meghalaya- 793101 (Code No. ERCAPP45/2012) with an annual intake of 100 students for (B.Ed.) course is hereby restored.
- 8. The terms and conditions of the order No. F. ERC/NCTE/ERCAPP45/2012/B.Ed.(Revised Order)/ 2015/31778 dt. 20.05.2015 issued to the institution shall remain same.
