#### **ORDER**

Whereas, the institution KRD College of Education, Chhaygaon, Kamrup, Assam-781124 (Code No. APE00155) was granted recognition for (B.Ed.) course of one year duration with an annual intake of 100 students vide ERC's order no. ERC/(ER-53.6(a).1)/2005/503(1) dt 10.02.2005 from the academic session 2005-2006.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide ERC's order no. ERC/NCTE/APE00155/B.Ed.(Revised Order)/2015/31776 dt. 20.05.2015 for conducting (B.Ed.) course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its  $274^{th}$  meeting held  $15^{th} 16^{th}$  July, 2019 considered the matter and decided as follows:-

"1st show cause notice u/s 17(1) issued on 10.05.2018, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following grounds:-

- (i) Faculty list duly approved by the concerned affiliating body not submitted.
- (ii) Building completion certificate duly approved by the Govt. Engineer is not submitted.
- (iii) Blue print of building plan in original duly approved by the Govt. Engineer is not submitted.
- (iv) FDRs towards Endowment and Reserve fund after conversion into joint mode not submitted.
- (v) Converted FDRs in joint operation mode is required to be uploaded on institution website.
- (vi) Teaching faculty and other required documents in PDF form not uploaded & updated on institution website.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

Accordingly, withdrawal order u/s 17(1) issued vide order no. F.No.ER-274.14.31/APE00155/ B.Ed./2019/61353 dt. 22.08.2019 from the academic session 2020-2021 to the institution.

- 4. And whereas, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 05.08.2019. The Appellate Authority vide its order no.89-373/E-133605/2019 Appeal/22<sup>nd</sup> November, 2019/85862 dt. 05.12.2019 remanded back the case to ERC for revisiting the matter taking into consideration the documents which the appellant institution is required to submit within 15 days of the issue of appeal order.
- 5. And whereas, the institution submitted reply vide letter dated 24.12.2019 received in ERC, NCTE on 30.12.2019. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> 16<sup>th</sup> February, 2020 considered the matter and decided to issue 1<sup>st</sup> Show Cause Notice after appeal and the same was issued on 27.02.2020 to the institution on the following grounds:-
  - (i) Principal is not eligible.
  - (ii) List of teaching faculty mentioned at Sl. No. I & 2 do not possess requisite percentage of marks as prescribed in regulation 2014.
  - (iii) Building Plan (BP) and Building Completion Certificate (BCC) duly signed by the competent authority to be submitted.
- 6. And whereas, the institution submitted reply vide letter dated 16.03.2020 & 04.08.2020 received in ERC, NCTE on 20.03.2020 & 17.08.2020 respectively. The ERC in its  $283^{rd}$  meeting held on  $24^{th}-25^{th}$  August, 2020 considered the matter and decided to issue Final Show Cause Notice and the same was issued on 15.09.2020 to the institution on the following grounds:-
  - (i) There is a mismatch between faculty list submitted by the institution and details of the same uploaded on its institutional website.
  - (ii) There is a mismatch of floor-wise and total built up area mentioned in Building Plan (BP) and Building Completion Certificate (BCC).
  - (iii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- 7. And whereas, the institution submitted reply through email vide letter dated 16.09.2020 received in ERC, NCTE on 17.09.2020. The ERC in its 284<sup>th</sup> Meeting held on 17<sup>th</sup> 18<sup>th</sup> September, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and decided as under:-

#### Restoration of Recognition Order of B.Ed. course to be issued.

7. Now therefore, recognition withdrawn vide order dated 22.08.2019 to the institution viz.KRD College of Education, Chhaygaon, Kamrup, Assam-781124 (Code No. APE00155) with an annual intake of 100 students for (B.Ed.) course is hereby restored.
