WHEREAS, Indira Gandhi Teachers Training Institute, Vill./P.O.- Nowda, City-Berhampur, Dist.- Murshidabad, West Bengal - 742183 (Code No.ERCAPP273) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order dated 30.01.2012, followed by revised order vide No. 32459 dated 30.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHERAS, the ERC in its 268th meeting held on 24th 25th February, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60141 dated 10.04.2019 from the academic session 2019-2020 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 10.04.2019. The Appellate Authority vide order No. 89-100/E-110931/2019 Appeal/21st Mtg.-2019/81264 dated 30.07.2019 remanded back the case to ERC for revising the matter, based on the submissions required to be made by appellant within 15 days for issue of appropriate order.
- 4. AND WHEREAS, the institution submitted reply dated 01.10.2019 received in this office on 09.10.2019. The ERC in its 277^{th} Meeting held on $19^{th} 20^{th}$ December, 2019 and as decided, show cause Notice u/s 17 was issued on 31.12.2019 to the institution on the following grounds:
 - a) Original list of members of faculty duly approved by the affiliating University need to be submitted.
 - b) FDRs in original along with Form 'A' need to be submitted.
 - c) Building Completion Certificate (BCC) is not visible.
- 5. AND WHEREAS, institution submitted reply vide letter dated 07.01.2020 & 13.02.2020 and received in this office on 10.01.2020 & 13.02.2020. The ERC in its 283^{rd} meeting held on $24^{th} 25^{th}$ August, 2020 and decided, final show cause notice was issued to the institution on 07.09.2020 on the following grounds:
 - a) There is a mismatch of floor-wise and total built up area mentioned in Building Plan (BP) and Building Completion Certificate (BCC).
 - b) Original list of teaching faculty duly approved by the concerned affiliating body to be submitted.
- 6. AND WHEREAS, the institution submitted reply dated 10.09.2020 and received in this office on 16.09.2020 in response to final show cause notice dated 07.09.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 284th meeting held on 17th & 18th September, 2020 and the committee decided as under:-
