WHEREAS, El-Bethel College, At./P.O.- Rasapunja, P.S.- Bishnupur, Kolkata, Dist.-South 24 Parganas, State- West Bengal- 700104 (Code No. APE00809) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC Order dated 28.02.2008, followed by revised order vide No. 32367 dated 29.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its  $279^{th}$  held on  $14^{th} - 16^{th}$  February, 2020, considered the matter and as decided, final show cause notice u/s 17(1) of NCTE Act, 1993. Accordingly final show cause notice was issued on 26.02.2020 to the institution on the following grounds:

- (i) Building plan approved by Govt. Engineer is not submitted.
- (ii) Submitted building completion certificate is without signature & seal of Govt. Engineer.
- (iii) Faculty list comprising 12 instead of 16 as per NCTE norms and also not approved by the convened affiliating body.
- (iv) FDRs of Rs. 5 lakh & Rs. 7 lakh towards endowment and reserve fund in joint operation mode as per NCTE Regulations, 2014 are not submitted.
- (v) Website not maintained and updated.
- (vi) Certificate copy of registered land document to be submitted.
- (vii) Certificate copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.

3. AND WHEREAS, the ERC in its  $284^{\text{th}}$  meeting held on  $17^{\text{th}} - 18^{\text{th}}$  September, 2020, considered the matter along with the reply dated 04.03.2020 received in this office on 11.03.2020 submitted by the institution in response to Final Show Cause Notice and observed as under:-

- (i) Building Plan (BP) has not been duly approved by the Govt. competent authority.
- (ii) Building Completion Certificate (BCC) has not
- (iii)been duly signed by the Govt. competent authority.
- (iv)List of teaching faculty member (1+10) which is less against the requirement of 1+15 for running two units of B.Ed. course as per Appendix-4 of Regulation, 2014.
- (v) Validity of fire Safety certificates has been expired on 15.06.2015.
- (vi)Validity of FDRs is expired.

In view of the above, the Committee decided as under:

Hence, B.Ed. Course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022.
