  - The institution has submitted its reply against the Show Cause Notice on 10.11.2022 stating that it submitted the PAR for the academic session 2020-21 vide application code No. P2021004700 under the short name of the institution "J.K.M. College of Management Science and Commerce" and submitted a copy thereof.

Committee examined the reply and decided that the Show Cause Notice on 04.08.2022 and Final Show Cause Notice dated 21.10.2022 issued to the institution for non-submission of Performance Appraisal Report (PAR) for the academic session 2020-21 be withdrawn.
