ORDER

WHEREAS, the Eastern Regional Committee, NCTE had granted recognition to **Dept. of Education, University of Calcutta, 1, Reformatory Street, Alipore, Kolkata, West Bengal-700027 (Code No. APE00134)** for conducting M.Ed. Course of one year duration with an annual intake 30 students from the academic session 2002-2003 vide order No.F.ERC/7-23/2002/1137 dt. 12.04.2002.

2. **AND WHEREAS**, on the basis of implementation of NCTE's Regulation 2014, Revised Recognition Order (RRO) was issued for conducting M.Ed. course of two years duration with an intake of 50 (one basic unit) from the academic session 2015-2016 vide No.F.ERC/NCTE/APE00134/M.Ed.(Revised Order)/2015/32326 dated 28.05.2015 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. **AND WHEREAS**, in compliance of RRO, reply vide letter dated 01.02.2018 submitted by the institution was considered by ERC in its 264th Meeting held on 5th - 6th December, 2018 and accordingly, show cause notice under section 17(1) of NCTE Act, 1993 was issued vide No.58635 dated 14.12.2018 to the institution on the following grounds:-

- i. Faculty list approved by the concerned affiliating body is not submitted.
- ii. Building plan approved by Govt. Engineer is not submitted.
- iii. Building completion certificate approved by Govt. Engineer in the NCTE prescribed proforma is not submitted.
- iv. No confirmation of website of the institution.

4. **AND WHEREAS**, the institution had failed to submit reply in response to SCN within stipulated period. The ERC in its 277th meeting held on 19th-20th December, 2019 considered the matter and accordingly, final show cause notice under section 17(1) of NCTE Act, 1993 was issued vide No.61980 dated 26.12.2019 to the institution on the following ground:-

- i. No reply has been received against the first show cause notice issued on 14.12.2018.

5. **AND WHEREAS**, the ERC in its 295th Meeting held on 21st August, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, non-submission of reply in response to final show cause notice and the Committee decided to **withdraw the recognition of M.Ed. course w.e.f. session 2021-2022.**

6. **NOW THEREFORE**, recognition granted to **Dept. of Education, University of Calcutta, 1, Reformatory Street, Alipore, Kolkata, West Bengal- 700027 (APE00134)** for **M.Ed. course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 w.e.f. **academic session 2021-2022**.

7. Further, if the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
