WHEREAS, the Eastern Regional Committee, NCTE had granted recognition to Chandradev Narayan College, Sahebganj, Plot No-216, Vill-Rampur Asli, Po.-Karnaul, Tehsil/Taluka-Sahebganj, Town/City-Sahebganj, Dist-Muzaffarpur, Bihar-843125 (Code No. ERCAPP1704) for conducting B.Ed. Course of one year duration with an annual intake 100 students from the academic session 2014-2015 vide order No. F. ERC/7-170.6.13/NCTE/B.Ed./2014/24388 dt.03.03.2014.

- 2. **AND WHEREAS**, on the basis of implementation of NCTE's Regulation 2014, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2015-2016 vide No.F.ERC/NCTE/ERCAPP1704/ B.Ed.(Revised Order)/2015/31987 dated 23.05.2015 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS**, in compliance of RRO, the institution did not submit reply and the matter was considered by ERC in its  $254^{th}$  Meeting held on  $16^{th}-17^{th}$  April, 2018 and accordingly, Show Cause Notice under section 17(1) of NCTE Act, 1993 was issued vide No.56749 dated 20.04.2018 to the institution to submit the following:
  - i. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
  - ii. Approved building plan by the concerned competent Govt. Engineer/ Authority.
- iii. Approved building completion certificate by concerned competent Govt. Engineer/ Authority.
- iv. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- v. Confirmation on website updates of the institutions with all details along with affidavit.
- 4. **AND WHEREAS**, the ERC in its 278<sup>th</sup> meeting held on  $16^{th} 18^{th}$  January, 2020 considered the matter and accordingly, a letter vide No. 62219 dated 01.02.2020 was issued to the institution to submit a duplicate copy of the reply submitted against the 1<sup>st</sup> Show Cause Notice issued on 20.04.2018 as per decision of 254<sup>th</sup> ERC meeting.
- 5. **AND WHEREAS,** the institution did not submit reply in response to ERC letter dated 01.02.2020. The ERC in its 284<sup>th</sup> Meeting held on 17<sup>th</sup> 18<sup>th</sup> September, 2020 considered the matter and accordingly, final show cause notice was issued vide no.63148 dated 08.10.2020 to the institution on the following grounds:
  - i. Latest teaching faculty list approved by the concerned affiliating body along with requisite testimonials to be submitted.
  - ii. Building Plan (BP) duly approved by the Govt. competent authority to be submitted.
- iii. Building Completion Certificate (BCC) duly signed by the Govt. competent authority to be submitted.
- iv. Original FDRs towards Endowment fund and Reserve fund after as prescribed m the NCTE Regulations, 2014 to be submitted.
- v. Requisite information of the institutional website as per clause 7(14)(i) of NCTE Regulation, 2014 to be updated.

6. AND WHEREAS, institution had failed to submit any reply in response to final show cause notice dt.08.10.2020. The ERC in its 295<sup>th</sup> meeting held on 21<sup>st</sup> August, 2021 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and non-submission of reply in response to final show cause notice and decided as under:-

"The ERC decided to withdraw the recognition of B.Ed. course w.e.f. session 2021-2022".

- 7. NOW THEREFORE, recognition granted to Chandradev Narayan College, Sahebganj, Plot No.-216, Vill.-Rampur Asli, Po.-Karnaul, Tehsil/Taluka -Sahebganj, Town/City-Sahebganj, Dist.-Muzaffarpur, Bihar-843125 (ERCAPP1704) for B.Ed. course is hereby withdrawn under section 17(1) of NCTE Act, 1993 w.e.f. academic session 2021-2022.
- 8. Further, if the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
