ORDER

WHEREAS, the Eastern Regional Committee, NCTE had granted recognition to Al-Momin College of Education, Mohalla Aminabad, At-Po-Bishunpura, Via-Chirki Bazar, Dist-Gaya, Bihar-824237 (Code No. APE00395) for conducting B.Ed. Course of one year duration with an annual intake 100 students from the academic session 2006-2007 vide order No. F. ERC/7-69.7.2/2006/3505 dt.03.10.2006.

- 2. **AND WHEREAS**, on implementation of NCTE's Regulation 2014, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2015-2016 vide No. F. ERC/NCTE/APE00395/B.Ed.(Revised Order)/2015/32734 dated 31.05.2015 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS**, recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 vide order no.54740 dated 18.10.2017 as per decision of 244th ERC meeting held on 08th 09th October, 2017.
- 4. **AND WHEREAS**, being aggrieved with the decision of ERC, the institution preferred an appeal and Appellate Authority vide order dt.16.03.2018 decided to set aside the impugned order of withdrawal dt.18.10.2017 with direction to ERC to examine all the adverse points mentioned in the VT report dt.05.04.2013, seeking clarification from the appellant institution by issuing a formal SCN and then issue appropriate reasoned order. Accordingly, SCN was issued to the institution on 02.05.2018. Reply of SCN vide letter dated 18.05.2018 submitted by the institution was considered by ERC in its 257th meeting and decided that recognition to B.Ed. course be continued from the academic session 2018-2019. Accordingly, continuance of recognition and restoration order was issued to the institution vide no.57698 dated 08.08.2018.
- 5. **AND WHEREAS**, a letter of complaint vide Ref. No.BSU/34/2018/2889/GS(I) dated 19.11.2018 from the Governors' Secretariat, Bihar Raj Bhawan, Patna against 39 recognised B.Ed. Teacher Education Institutions (including this institution) in the State of Bihar affiliated to different Universities received through NCTE Hqrs. vide letter No.NCTE-Regl011/11/2019-US(Regulation)-HQ/78664 dated 16.05.2019 for taking necessary action against the institutions for non-compliance of the directions of the Hon'ble Chancellor, Raj Bhawan, Patna for ensuring transparent compliance of NCTE norms.
- 6. **AND WHEREAS,** the ERC in its 266th meeting held on 31st January, 2019 considered the matter and accordingly, Show Cause Notice u/s 17(1) was issued vide no. 59245 dated 08.02.2019 to the institution on the grounds mentioned therein.
- 7. **AND WHEREAS,** reply dated 27.02.2019 in response to SCN submitted by institution was considered by ERC in its 270th meeting held on 25-26 March, 2019 and accordingly letter vide no.60190 dated 11.04.2019 was issued intimating that all points as per NCTE Regulations 2014, mentioned in the Show Cause Notice, have been complied by the institution.

- 8. **AND WHEREAS**, a letter of complaint vide Ref. No.BSU/34/2018/794/GS(I) dated 06.03.2019 from the Governors' Secretariat, Bihar Raj Bhawan, Patna against 16 recognised B.Ed. Teacher Education Institutions in the State of Bihar (including this institution) affiliated to different Universities received through NCTE Hqrs. vide letter No.NCTE-Reg1011/11/2019-USA(Regulation)-HQ/78664 dated 16.05.2019 for taking necessary action by issuing show cause notice u/s 17(1) of the NCTE Act, 1993 and for taking appropriate decision as per NCTE Act/Regulations by ERC.
- 9. AND WHEREAS, the ERC in its 272nd meeting held on 30th-31st May & 1st June, 2019 considered the matter and accordingly, Show Cause Notice u/s 17(1) was issued to the 16 institutions (including this institution) on 18.06.2019 to comply fulfilment of the conditions mentioned under clause 7(14)(i) of NCTE Regulations, 2014 and display the same on their official website.
- **10. AND WHEREAS**, the ERC in its 282nd meeting held on 8th-9th July, 2020 considered the complaint matter against the institution received through NCTE Hqrs. and accordingly, Show Cause Notice u/s 17(1) was issued to the institution on 13.08.2020 with direction to submit the following:
 - i. Approved faculties list of the institution to be submitted.
 - ii. Certified copy of registered land documents to be submitted.
 - iii. Land possession/mutation certificate to be submitted.
 - iv. Change of Land Use Certificate issued from Land Revenue/concerned Govt. department to be submitted.
 - v. Non-encumbrance certificate in the name of institution/society issued from the Land Registering Authority to be submitted.
 - vi. Experience Certificate of the Principal to be submitted.
- vii. A copy of affiliation letter of CBSE School mentioning full details.
- viii. A certified copy of land documents in r/o Nizamia College of Education.
- ix. Permission letter of Girls school namely Hazrat Ayesha Girls schools Khagaul, Patna.
- 11. AND WHEREAS, reply vide letter dated 02.09.2020 in response to Show Cause Notice dt.13.08.2020 was submitted by the institution. The ERC in its 295th meeting held on 21st August, 2021 considered the original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and considered the reply received from the institution in response to SCN and following observations were made:-
 - "After the show cause notice, up to date faculty list, approved by the affiliating university is wanting. Also in search it is found that the website of the institution is not functional, hence the ERC decided to withdraw the recognition from the academic session 2021-2022."
- 12. NOW THEREFORE, recognition granted to Al-Momin College of Education, Mohalla Aminabad, At-Po-Bishunpura, Via-Chirki Bazar, Dist-Gaya, Bihar 824237 (APE00395) for B.Ed. course is hereby withdrawn under section 17(1) of NCTE Act, 1993 w.e.f. academic session 2021-2022.
- 13. Further, if the institution is not satisfied with the order, it may prefer an appeal under Section 18 of NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
- 14. The original FDRs of Rs.5.00 lakh bearing A/c no. 2300300019385 dated 01.09.2015 and Rs.7.00 lakh bearing A/c no.12300300019386 dated 01.09.2015 submitted towards Endowment and Reserve Fund by the institution in joint operation mode issued by Bank of Baroda Gaya are enclosed herewith.
