**Change of Name of the Institution**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Bhuvanmalti Teachers Training College, Plot No.-21, Street No.-1, Vill.-Basatpur Badatola, P.O.-Rupdih, Tehsil/Taluka-Mothari, Town/City-Motihari, Dist.-PurbaChampan, Bihar-845408 was granted recognition for D.El.Ed. programme of two years duration with an intake of 50 vide ERC Order No. ER-239.6.6/ERCAPP2465/D.El.Ed./2017/52760 dated 02.05.2017, as per NCTE Regulations, 2014.
