ORDER

Change of Name of the Institution

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, **Bhuvanmalti Teachers Training College, Plot No.-21, Street No.-1, Vill.-Basatpur Badatola, P.O.-Rupdih, Tehsil/Taluka - Mothari, Town/City-Motihari, Dist.-Purba Champaran, Bihar-845408** was granted recognition for B.Ed. programme of one year duration with an intake of 100 *vide* ERC Order No. ERC/7-169.6.14/NCTE/B.Ed./2014/24159 dated 24.02.2014, followed by revised recognition for B.Ed. programme of two years duration with an intake of 100 students (Two basic units) from the academic session 2015-2016 *vide* order No.ERC/NCTE/ERCAPP1413/B.Ed.(Revised Order)/2015/31938 dated 23.05.2015, as per NCTE Regulations, 2014.

2. AND WHEREAS, institution has submitted representation dated 09.09.2022 along with relevant documents regarding Change of name from **Bhuvanmalti Teachers Training College, Motihari, Bihar-845408** to **Bhuvan Malti College of Education**.

3. AND WHEREAS, the matter was considered by the ERC in its 321st(Virtual) meeting of the ERC held on 21.02.2023 and the committee decided as under:-

“The original file of the institution alongwith other related documents, correction deed of land documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee decided that:

- *The institution be permitted to change the name of institution from “Bhuvan Malti Teachers Training College” to “Bhuvan Malti College of Education” for running B.Ed. &D.El.Ed. programme.Orders may be issued accordingly.”*

4. NOW THEREFORE, permission is granted for change of name of the institution from "**Bhuvanmalti Teachers Training College, Motihari, Bihar-845408**" to "**Bhuvan Malti College of Education** for running B.Ed programme.
