ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted toDr Shahidullah Institute of Education, Plot No.-2101, Vill.-Aminpur, P.O.-Sondalia, Tehsil/Taluka-Bahira, Town/City-Sashan, Dist.-North 24 Parganas West Bengal-743423 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (TwoBasic Units of 50 Students Each) from the academic session 2018-2019videorder ER-252.6.30(Part-3)/ERCAPP2610/B.Ed./2018/56326 dated 03.03.2018, as per NCTE Regulations, 2014.

2. AND WHEREAS, recognition of the institution was withdrawn vide Order No.F.No.ER-313.43/NCTE/ERCAPP2610/B.Ed./WB/2022/66826 dated 24.11.2022.

3. AND WHEREAS, the institution preferred an appeal to NCTE Hors against withdrawal order dated 24.11.2022. The Appellate Authority has passed an order vide its order No. F.NO.89-23/E-288637/2023 Appeal/1st Meeting, 2023, dated 09.02.2023. The operative part of order as under:-

"... In view of the afore-mentioned extracts of the court orders, the impugned withdrawal order dated 24.11.2022 is set-aside and the Appellate Committee has decided to remand back the case to ERC for revisiting the matter.

The Appellate Committee observed that the appellant institution has submitted documents as required by the final show cause notice dated 09.04.2022 and accordingly, the matter be remanded back to the Eastern Regional Committee, Accordingly, the ERC is directed to revisit the matter to take further necessary action as per regulation, 2014, Further, the appellant is directed to submit to ERC the above documents within 15 days from the issue of appeal order.

Appeal Committee of the Council concluded that the appeal deserves to be allowed and the matter be remanded back to ERC. Further, ERC is hereby directed to issue a speaking order after consideration the documents submitted by the appellant institution and take an appropriate action with respect to NCTE Regulations, 2014 guidelines and amendment issued from time to time".

4. AND WHEREAS, the institution submitted its reply dated 10.02.2023 received in ERC office on dated 13.02.2023. The matter was considered by the ERC in its 321st (Virtual) meeting of the ERC held on 21.02.2023 and the committee decided as under:-

"The original file of the institution alongwith Appeal Order No. F. No. 89-23/E-288637/2023 Appeal/1st Meeting, 2023/APPLERC202214491 dated 09.02.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

• The Committee noted that the withdrawal order 24.11.2022 has already been set aside by the Appellate Authority vide its Order dated 09.02.2023 and remanded back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is hereby restored. Orders may be issued accordingly.

5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Dr Shahidullah Institute of Education, Plot No.-2101, Vill.-Aminpur, P.O.-Sondalia, Tehsil/Taluka-Bahira, Town/City-Sashan, Dist.-North 24 Parganas West Bengal-743423 vide order No. ER-252.6.30(Part-3)/ERCAPP2610/B.Ed./2018/56326 dated 03.03.2018 for B.Ed. programme with an annual intake of 100 students (two units) is hereby restored.
