**ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Kabi Samrat Upendra Bhanja College of Teacher Education, Bhanjanagar, Plot No.-321-1, Street No.-Lalsingh, Vill.-Bhanjanagar, P.O.-Bhanjanagar, Tehsil/Taluka-Bhanjanagar, Town/City-Bhanjanagar, Dist.-Ganjam, Odisha-761126 for conducting B.Ed. programme of one year duration with annual intake of 72 seats vide Order No. 742 dated 31.05.1996 from academic session 1996-97, followed by revised recognition for B.Ed. programme of two years duration with an annual intake of 100 students (Two Basic Units of 50 Students Each) from the academic session 2015-2016 vide Order No. ERC/NCTE/OR-S/E-2/96 & ERCAPP1862/B.Ed./32697 dated 31.05.2015, as per NCTE Regulations, 2014.

2. AND WHEREAS, recognition of the institution was withdrawn vide Order No. F.No.ER-274.14.1/(ORS/E-2/96 & ERCAPP1862)/B.Ed./2019/61356 dated 22.08.2019.

3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's withdrawal order dated 22.08.2019. The Appellate Authority vide its Order No. F.No.-89-384/E-136819/2019 Appeal/35th November, 2019/86008 dated 13.12.2019 decided to confirm the withdrawal order dated 28.08.2019. The institution submitted its reply dated 27.12.2019 and 06.01.2020.

4. AND WHEREAS, the institution preferred an appeal before NCTE (HQ) against withdrawal order of ERC dated 28.08.2019. The Appeal Authority vide its order No.. 89-149/E-257188/2022 Appeal/9<sup>th</sup> Meeting, 2022/APPLERC202214377/115740 dated 05.12.2022 passed and order as under:-

*"...In view of the afore-mentioned extracts of the court orders, the impugned withdrawal order dated 28.08.2019 is set-aside and the Appellate Committee has decided to remand back the case to ERC for revisiting the matter.*

*Appeal Committee of the Council concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to*

*the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verify the submitted documents from the concerned issuing authority."*

5. AND WHEREAS, in compliance of the order of the Appellate Authority, the institution submitted a representation dated 10.12.2022 received in a ERC office on dated 14.12.2022. The matter was considered by the ERC in its 321<sup>st</sup> (Virtual) meeting of the ERC held on 21.02.2023 and the committee decided as under:-

*"The original file of the institution alongwith Appeal Order No. 89-149/E-257188/2022 Appeal/9th Meeting, 2022/APPLERC202214377/115740 dated 05.12.2022, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.*

- The Committee noted that the withdrawal order 22.08.2019 has already been set aside by the Appellate Authority vide its Order dated 05.12.2022 and remanded back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is hereby restored. Orders may be issued accordingly."*

6. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Kabi Samrat Upendra Bhanja College of Teacher Education, Bhanjanagar, Plot No.-321-1, Street No.-Lalsingh, Vill.-Bhanjanagar, P.O.-Bhanjanagar, Tehsil/Taluka-Bhanjanagar, Town/City-Bhanjanagar, Dist.-Ganjam, Odisha-761126 vide order No .ERC/ NCTE/ OR-S/E-2/96 & ERCAPP1862/B.Ed.(Revised Order)/2015/32697 dated 31.05.2015 for B.Ed. programme with an annual intake of 100 students (two units) is hereby restored.
