#### **ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to College of Teacher Education, Balangir, Odisha-767001 for conducting B.Ed. programme of one year duration *vide* order No. ERC/7-57.5.5/2005/1929 dated 21.06.2005 from academic session 2005-2006, followed by revised recognition for B.Ed. programme of two year duration with an annual intake of 100 students (Two Basic Units of 50 Students Each) from the academic session 2015-2016 *vide* order No. ERC/NCTE/OR-S/E-6/96 & APE00346/B.Ed. (Revised Order)/2015/32760 dated 31.05.2015 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, recognition of the institution was withdrawn *vide* Order No.F.No.ER.278.51/OR-S/E-6/96 & APE00346/B.Ed./2020/62160dated 28.01.2020.
- 3. AND WHEREAS, the institution preferred an appeal before NCTE (HQ) against withdrawal order of ERC dated 28.01.2020 which was remanded back by the appellate authority *vide* its appeal Order No. F.No.-89-219/E-193007/2021 Appeal/19<sup>th</sup>Meeting, 2021/Appeal No. APPLER C202114069/101328 dated 19.08.2021.
- 4. AND WHEREAS, in compliance of the order of the Appellate Authority, the institution has submitted its reply dated 20.08.2021. The matter was considered by the ERC in its 295<sup>th</sup> Meeting held on 21<sup>st</sup> August, 2021 and the committee decided as under:-

The original file of alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 19.08.2021 were carefully considered by the ERC and Committee decided as under:-

Restoration of recognition order for B.Ed. course with an annual intake of 50 (one basic unit) be issued.

Accordingly, Restoration Order was issued on dated 31.08.2021.

**5. ANDWHEREAS**, the institution preferred an appeal before NCTE (HQ) against Restoration order of ERC dated 31.08.2021. The Appeal Authority *vide* its order .No.-89-185/E-259051/2022 Appeal/9<sup>th</sup>Meeting, 2022/APPLER C202214380/ 115492 dated 30.11.2022 passed an order as under:-

"...Appeal Committee of the Council concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verity the submitted documents from the concerned issuing authority."

6. AND WHEREAS, in compliance of the order of the Appellate Authority, the institution submitted its reply dated 06.12.2022 received in ERC office on dated 13.12.2022. The matter was considered by the ERC in its 321<sup>st</sup> (Virtual) meeting of the ERC held on 21.02.2023 and the committee decided as under:-

"The original file of the institution alongwith Appeal Order No.89-185/E-259051/2022 Appeal/9<sup>th</sup> Meeting, 2022/APPLERC202214380/115492 dated 30.11.2022, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

- The Committee noted that the order 28.08.2019 has already been set aside by the Appellate Authority vide its Order dated 19.08.2021 which was considered by ERC and restoration order dated 31.08.2021 was issued for 50 seats. The institution filed an appeal against restoration order wherein the Appeal Committee passed Order dated 30.11.2022 and remanded back to ERC for consideration. In compliance of appeal order, ERC decided that the recognition granted to the institution for running 100 seats in B.Ed. programme is hereby restored. Orders may be issued accordingly."
- 7. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. College of Teacher Education, Balangir, Odisha-767001vide order No.ERC/NCTE/OR-S/E-6/96 & APE00346/B.Ed. (Revised Order)/2015/32760 dated 31.05.2015for B.Ed. programme with an annual intake of 100 students (two units) is hereby restored.
