ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to College of Teacher Education, Rourkela, Plot No. -132P, Street No.-Sector-21, Vill.-Rourkela, PO- Rourkela, Tehsil/Taluka-Rourkela, Town/City- Rourkela, Dist.-Sundargarh, Odisha-769001 for conducting B.Ed. programme of one year duration vide order Vide Order No. 1543 dated 31.05.1996 from academic session 1997-98, followed by revised recognition for B.Ed. programme of two year duration with an annual intake of 100 students (Two Basic Units of 50 Students Each) from the academic session 2015-2016 vide order No. ERC/NCTE/OR-S/E-9/96 & ERCAPP1868/B.Ed./32742 dated 31.05.2015 as per NCTE Regulations, 2014.

2. AND WHEREAS, recognition of the institution was withdrawn vide Order No.F.No.ER.275.14.33/OR-S/E-9/96 & APP1868/B.Ed./2019/61433 dated 28.08.2019.
3. AND WHEREAS, the institution preferred an appeal before NCTE (HQ) against withdrawal order of ERC dated 28.08.2019 which was confirming the withdrawal order by the appellate authority vide its appeal Order No. F.No.-89-409/E-139007/2019 Appeal/36thMtg.-2019/26th November, 2019/86080 dated 13.12.2019. The institution has submitted reply in response to appeal order on dated 28.07.2022 & 04.11.2022.
4. AND WHEREAS, the institution again preferred an appeal before NCTE (HQ) against withdrawal order of ERC dated 28.08.2019. The Appeal Authority vide its order .No. 89-199/E-262949/2022 Appeal/9th Meeting, 2022/APPLERC202214401/115520 dated 30.11.2022 passed an order as under:-

“..In view of the afore-mentioned extracts of the court orders, the impugned withdrawal order dated 28.08.2019 is set-aside and the Appellate Committee has decided to remand back the case to ERC for revisiting the matter.

Appeal Committee of the Council concluded that the appeal deserves to be allowed and the matter be remanded back to ERC. Further, ERC is hereby directed to issue a speaking order after consideration the documents submitted by the appellant institution and take an appropriate action with respect to NCTE Regulations, 2014 guidelines and amendment issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verify the submitted documents from the concerned issuing authority”

5. **AND WHEREAS**, the institution submitted its reply dated 10.12.2022 received in ERC office on dated 14.12.2022. The matter was considered by the ERC in its 321st (Virtual) meeting of the ERC held on 21.02.2023 and the committee decided as under:-

“The original file of the institution alongwith Appeal Order No.89-199/E-262949/2022 Appeal/9thMeeting, 2022/APPLERC202214401/115520 dated 30.11.2022, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.


The Committee noted that the withdrawal order 28.08.2019 has already been set aside by the Appellate Authority vide its Order dated 30.11.2022 and remanded back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is hereby restored. Orders may be issued accordingly.”

6. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to the institution viz. **College of Teacher Education, Rourkela, Plot No. -132P, Street No.-Sector-21, Vill.-Rourkela, PO- Rourkela, Tehsil/Taluka-Rourkela, Town/City- Rourkela, Dist.-Sundargarh, Odisha-769001** vide order No.No. /NCTE/OR-S/E-9/96 & ERCAPP1868 /B.Ed. /32742 dated 31.05.2015 for B.Ed. programme with an annual intake of 100 students (two units) is hereby restored.
