**ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Dibakar Patnaik Institute of Advanced Studies in Education, Plot No.-284, Street No.-NH-5, Vill.-KonisiHata, PO-Konisi, Tehsil/Taluka-Konisi, Town/City- Berhampur, Dist.-Ganjam, Odisha-761008** for conducting B.Ed. programme of one year duration vide Order No. 724 dated 31.05.1996 for academic session 1996-97, followed by revised recognition for B.Ed. programme of two years duration with an annual intake of 100 students (Two Basic Units of 50 Students Each) from the academic session 2015-2016 vide Order No. ERC/NCTE/OR-S/E-11/96 & ERCAPP1886/B.Ed. (Revised Order)/2015/32766 dated 31.05.2015, as per NCTE Regulations, 2014.

2. AND WHEREAS, recognition of the institution was withdrawn vide Order No. F.No.ER-278.6/(OR-S/E-11/96 & ERCAPP1886)/B.Ed./2020/62142 dated 28.01.2020.

3. AND WHEREAS, the institution preferred an Appeal Order F.No.-89-209/E-192105/2021 Appeal/19<sup>th</sup> Meeting, 2021/Appeal No. APPLERC202114073/101308 dated 19.08.2021, in view of the above, the Committee decided as under:

*“...In compliance of the orders dated 08.04.2021 & 30.07.2021 of Hon’ble High Court of Delhi in W.P. (C) Nos. 4382/2021 & 7260/2021 respectively, Appeal Committee decided to set aside the impugned order dated 28.01.2020, therefore, the institution is entitled to the benefits of recognition proportionate to the number of faculty as per NCTE Regulations, 2014 until a fresh withdrawal order is passed by the Regional Committee. The case of the institution is remanded back to ERC for revisiting the matter for restoration of recognition (of one unit) which is proportionate to the number of faculty appointed with the approval of affiliating body. Appellant institution is required to submit to ERC the list of faculty approved by affiliating body.”*

4. AND WHEREAS, the institution submitted a representation dated 20.08.2021, the matter was considered by the ERC in its 295<sup>th</sup> Meeting held on 21<sup>st</sup> August, 2021 and the committee decided as under:-

*“The original file along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 19.08.2021 were carefully considered by the ERC and Committee decided as under:-*

*Restoration of recognition order for B.Ed. course with an annual intake of 50 (one basic unit) be issued.”*

Accordingly, Restoration Order was issued to the institution on 31.08.2021.

5. AND WHEREAS, the institution preferred an appeal before NCTE (HQ) against Restoration order of ERC dated 31.08.2021. The Appeal Authority vide its order .No. F.No.-89-168/E-258161/2022Appeal/9<sup>th</sup>Meeting,2022/APPLERC202214399/115756 dated 05.12.2022 passed an order as under:-

*"...In view of the afore-mentioned extracts of the court orders, the impugned withdrawal order dated 28.01.2020 is set-aside and the Appellate Committee has decided to remand back the case to ERC for revisiting the matter.*

*"Appeal Committee of the Council concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verify the submitted documents from the concerned issuing authority."*

6. AND WHEREAS, the institution submitted its reply dated 10.12.2022 received in ERC office on dated 14.12.2023. The matter was considered by the ERC in its 321<sup>st</sup> (Virtual) meeting of the ERC held on 21.02.2023 and the committee decided as under:-

*"The original file of the institution alongwith Appeal Order No. 89-168/E-258161/2022 Appeal/9<sup>th</sup>Meeting, 2022/APPLERC202214399/ 115756 dated 05.12.2022, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.*

- The Committee noted that the order 28.01.2020 has already been set aside by the Appellate Authority vide its Order dated 19.08.2021 which was considered by ERC and restoration order dated 31.08.2021 was issued for 50 seats. The institution filed an appeal against restoration order wherein the Appeal Committee passed Order dated 05.12.2022 and remanded back to ERC for consideration. In compliance of appeal order, ERC decided that the recognition granted to the institution for running 100 seats in B.Ed. programme is hereby restored. Orders may be issued accordingly."*

7. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Dibakar Patnaik Institute of Advanced Studies in Education, Plot No.- 284, Street No.-NH-5, Vill.-KonisiHata, PO.-Konisi, Tehsil/Taluka-Konisi, Town/City-Berhampur, Dist.-Ganjam, Odisha-761008 vide order No.ERC/NCTE/OR-S/E-11/96 & ERCAPP1886/B.Ed.(Revised Order)/2015/32766 dated 31.05.2015for B.Ed. programme with an annual intake of 100 students (two units) is hereby restored.
