WHEREAS, Gour Malda College of Education, Vill- Kamalpur, Kamalbari, P.O.-Meherapur, Dist- Malda, West Bengal- 732207 (Code No.APE00889) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC Order dated 15.01.2010, followed by revised recognition order issued on 23.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. AND WHERAS, the ERC in its 275th meeting held on 27th July, 2019 considered the matter and as decided, the intake for B.Ed. course be reduced from 100 to 50 from the academic session 2020-2021 with intimation to the institution and all concerned. Accordingly, vide ERC order No. 61489 dated 02.09.2019 issued to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 32.09.2019. The Appealate Authority vide order No. 89-399/E-138036/2019 Appeal/36th Mtg.-2019/26th November, 2019/86052 dated 13/12/2019 remand back the case to ERC for revisiting the matter after receiving the list of faculty required to be submitted by appellant within 15 days of the issue of Appeal order.
- 4. AND WHEREAS, the institution submitted reply dated 22.12.2019 & 04.02.2020 received in this office on 30.12.2019 & 10.02.2020. The ERC in its 279th Meeting held on 14th 16th February, 2020 and decided, a letter was issued on 05.03.2020 to the institution on the following grounds:
 - d) A letter be issued to the institution with a direction to renew the original FDRs Rs. 5 lakh and Rs. 7 lakh and to submit it within 21 days.
- 5. AND WHEREAS, institution submitted reply vide letter dated 07.08.2020 and received in this office on 11.08.2020. The ERC in its 283^{rd} meeting held on $24^{rh} 25^{th}$ August, 2020 and decided, final show cause notice was issued to the institution on 15.09.2020 on the following grounds:
 - c) List of faculty submitted by the institution in which Sl. No. 9 does not possess requisite percentage of marks in P.G. degree.
- 6. AND WHEREAS, the institution submitted reply dated 15.09.2020 and received in this office on 16.09.2020 in response to final show cause notice dated 15.09.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 284th meeting held on 17th & 18th September, 2020 and the committee decided as under:-
 - > Restoration of Recognition Order for B.Ed. Course for another one unit (50 intake) to be issued. Hence, the total two units (100 intake) is permitted.
