**ORDER**

WHEREAS, the institution Maryada Purushotam College of Education, Plot No. 1245, 1246,1247,1248, Vill/PO–Chilhari, Tehsil/Taluka–Dumraon, Town/City–Buxar, Dist–Buxar, Bihar–802101 (ERCAPP7/2012) was granted recognition for conducting B.Ed. course with intake of 100 from the academic session 2014-2015 followed by revised recognition order issued on 20.05.2015 from the academic session 2015-2016.


2. AND WHEREAS, in response to the compliance of the revised recognition, institution has not submitted any reply the ERC in its 255<sup>th</sup> meeting held on 30<sup>th</sup> April – 02<sup>nd</sup> May, 2018. The matter was considered by ERC and as per decision of the Committee; Show Cause Notice was issued to the institution on 15.05.2018. Meanwhile, a complaint received from the Governor Secretariat, Bihar on 24.05.2019 against the institution.

3. AND WHEREAS, the ERC in its 272<sup>nd</sup> meeting held on 30<sup>th</sup> May – 01<sup>st</sup> June, 2019 considered the complaint and as decided to issue Show Cause Notice to the institution and accordingly, Show Cause Notice issued to the institution on 18.06.2019.

4. AND WHEREAS, institution not submitted any reply in response to Show Cause Notice. The ERC in its 278<sup>th</sup> meeting held on 16<sup>th</sup>–18<sup>th</sup> January, 2020 considered the matter and as per decision of the Committee, Final Show Cause Notice was issued to the institution on 28.01.2020.

5. AND WHEREAS, institution submitted representation dt.14.02.2020 received on 17.02.2020 stating that institution already submitted reply on 04.06.2018. The matter was placed in 280<sup>th</sup> ERC meeting held on 29<sup>th</sup> February – 01<sup>st</sup> March, 2020 and as decided by the Committee a letter was sent to the institution on 06.03.2020 to submit a duplicate copy of the reply submitted against the 1<sup>st</sup> Show Cause Notice issued on 15.05.2018 decided in the 255<sup>th</sup> ERC meeting on the following points:-

- i. Blue print of Building plan in original duly approved by the Govt. Engineer is not submitted.
- ii. Building Completion Certificate duly approved by the Govt. Engineer is not submitted.


- iii. Faculty list duly approved by the concerned affiliating body not submitted.
- iv. FDRs towards Endowment and Reserve Fund after conversion into joint mode not submitted.
- v. Converted FDRs in joint operation mode is required to be uploaded on institution website.
- vi. No website address of the institution has been provided.

6. AND WHEREAS, institution not submitted any reply in response to the letter. The ERC in its 284<sup>th</sup> meeting held on 17<sup>th</sup> – 18<sup>th</sup> September, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:-

- A. First show cause notice issued on 15.05.2018.
- B. Final show cause notice issued on 28.01.2020.
- C. Institution letter dated 14.02.2020 stating that they have submitted a reply against the first SCN.
- D. A letter dated 06.03.2020 from ERC, NCTE sent to the institution with a request you to submit a duplicate copy of reply against first SCN dated 15.05.2018.
- E. However. no reply received by the ERC against the final SCN issued on 28.01.2020.
- F. Further, no opportunity to be given to the institution as the institution has not complied against the final SCN on the following grounds: -
  - i. Original list of teaching faculty duly signed by the concerned affiliating body is not submitted.
  - ii. Original Building Plan (BP) duly signed by the competent authority is not submitted.
  - iii. Building Completion Certificate (BCC) duly signed by the competent authority is not submitted.
  - iv. Original FDRs of Rs.5 lakh and Rs. 7 lakh is not submitted.
  - v. Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority is not submitted.
  - vi. Website of the institution is not functional as per clause 7(14)(i) of the NCTE Regulation, 2014.

**“Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.”**


7. NOW THEREFORE, recognition granted to Maryada Purushotam College of Education, Plot No.1245,1246,1247,1248, Vill/PO-Chilhari, Tehsil/Taluka-Dumraon, Town/City-Buxar, Dist-Buxar, Bihar-802101 (ERCAPP7/2012) for B.Ed. Course is hereby withdrawn in terms of 17(1) of NCTE Act, 1993 with effect from the academic session 2021-2022.


