ORDER

WHEREAS, Ashu Kisku Memorial and Rabi Kisku Teachers Training Institute, Plot No.327/47. Vill-Lupungdih, PO- Tankacha, Tehsil/Taluka- Chandil, City- Chandil, Distt.-Pashchim Singhbhum, Jharkhand-832401 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.18905 dated 14.06.2013 from the academic session 2014-15, followed by revised recognition order vide No.32369 dt. 29.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- AND WHEREAS, the ERC in its 279th meeting held on 14th-16th February, 2020, decided that 2 recognition granted to B.Ed. course be withdrawn from the academic session 2020-2021. Accordingly withdrawal order issued vide No.62391 dt. 26.02.2020.
- AND WHEREAS, institution preferred appeal against the withdrawal order at NCTE HQrs. and the Appellate Authority vide order No. 89-73/E-156208/2020 Appeal/13th Mtg.-2020/27th July, 2020/93092 dated 15.09.2020 remanded back the case to ERC for revisiting the matter.
- AND WHEREAS, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 15.09.2020 and decided that restoration of recognition order of B.Ed. course with annual intake of 100 students (02 units) be issued.
- AND WHEREAS, the ERC in its 287th meeting held on 14th December, 2020 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 15.09.2020 and decided that matter be placed in the next meeting with comprehensive agenda covering all the aspects of the case. The matter was deferred for next meeting as decided by ERC in its 288th meeting held on 29th January, 2021.
- AND WHEREAS, the ERC in its 291st meeting held on 12th April, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 15.09.2020 and comprehensive agenda note and decided that legal opinion be sought from Legal Counsel on dispute within the Members of the Management of institution. Accordingly, letter vide no. 64075 dated 29.04.2021 was issued to Shri Sidharth Sankar Mohapatra, Legal Counsel, NCTE at Orissa High Court. In response, reply received from the Legal Counsel vide letter dated 14.10.2021.
- AND WHEREAS, institution filed a petition W.P.(C) No.12057 of 2021 at Hon'ble High Court of Delhi and the Hon'ble Court disposed of the case vide Order dt.27.10.2021 with following observations:

"The Court has directed vide order dated 27.10.2021 to issue an order of restoration of recognition within one week and to reflect the correct status of the petitioner on its website as well as communicate it to the petitioner's affiliating university and to concerned State Government. The petitioner will also be allowed to participate in the counselling and admitting students for the year 2021-22."
