ORDER

Change of premises of the institution

Mahila Mahavidyalay, At-Mudila, PO-Amba, Dist.-Aurangabad, Bihar-824111 (Code No. APE00740) granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC order No. ERC/7-104.4(i).15/2010/3223 dated 30.01.2010 as per decision taken in the 88th ERC meeting held on 28-29 August 2008.

The aforesaid institution had submitted application dated 19.06.2013 for shifting of premises along with requisite documents.

The ERC in its 186th meeting decided that VT to be constituted. Accordingly, the inspection of the institution at new premises was conducted on 25.05.2015 and VT report received at ERC, NCTE on 28.05.2015.

The ERC in its 191st meeting held on 14-15 July after considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs., VTR, the Committee discussed the matter in detail and decided as under:

“Shifting of premises is permitted”.

In view of the above, the institution is hereby permitted shifting of premises of the institution from “Mahila Mahavidyalay, At-Mudila, PO-Amba, Dist.-Aurangabad, Bihar-824111” to **“Mahila Mahavidyalaya, Plot No. 115, Vill/Town/City- Silar, Po- Silar via S. Sinha College, Tehsil/Taluka Aurangabad, Dist.- Aurangabad, Bihar-824101”.**
