ORDER

WHEREAS, Daying Ering College of Teacher Education, Diking, Pasighat, Arunachal Pradesh-791102 (Formerly: Doying Gumin College, P.O.-Pasighat, East Siang, Arunachal Pradesh – 791102) (APE00564) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC order dated 30.08.2008, followed by revised recognition order issued on 09.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS,** the ERC in its 271st meeting held on 24th 25th April, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60510 dated 21.05.2019 from the academic session 2019-2020 to the institution.
- 3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 21.05.2019. The Appellate Authority vide order No.89-192/E-117536/2019 Appeal/17th Mtg.-2019/12th June, 2019/80290 dated 05/07/2019 remanded back to the ERC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC, all the documents submitted in the appeal, with originals thereof, wherever necessary, within 15 days of receipt of the orders on the appeal.
- 4. **AND WHEREAS**, the ERC in its 275th (Part 2) meeting held on 27th July, 2019 considered the matter and as decided, Show Cause Notice was issued on 11.09.2019 to the institution on the following grounds:
 - (i) Individual affidavit on Rs.10/- stamp paper of newly appointed faculty including Principal not submitted.
 - (ii) Blue print building plan is not approved by competent Govt. Engineer.
- 5. **AND WHEREAS,** the institution submitted reply vide letter dated 20.09.2019 & 25.09.2019 received in this office on 01.10.2019 & 09.10.2019. The ERC in its 280th meeting held on 29th February & 1st March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-

"Restoration of recognition order of B.Ed. course to be issued".
