Aalo, Plot No. 05/09, Street No. Aalo, Vill-Bogdo, Po- Aalo, Tehsil/Taluka-Aalo, Dist-West-Siang, Arunachal Pradesh-791001 (ERCAPP876) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No. 13371dated 18/08/2012, followed by revised order vide No.31607 dated 09.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 263th meeting held on 15th 16th November, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 27/11/2018 to the institution on the following grounds:
 - Building plan submitted is in piecemeal and not legible. Consolidated building plan in (i) readable form duly approved by Govt. Engineer is to be submitted.
- AND WHEREAS, the ERC in its 279th Meeting held on 14th -16th February, 2020. considered the matter and reply received on dated 03/10/2019 from the institution in response to Show Cause Notice dated 27/11/2018 and observed as under.
 - > 1st show cause notice u/s 17(1) issued on 20/04/2018 follow by Final show cause notice issued dated 27/11/2018 and the institution is still deficient on the following ground:-
 - (i) Total built up area mentioned in the Building Plan (BP) as well as Building Completion Certificate (BCC) as 1756.97 Sq. Mts., which is not sufficient to run 02 units of B.Ed.
 - (ii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

NOW THEREFORE, recognition granted to the institution viz. Teachers Training B.Ed. College B.Ed. Aalo, Plot No.- 05109, Street No.-Aalo, Vill.- Bogdo, PO.- Aalo, Tehsil/Taluka-Aalo, Dist.- West Siang, Aunlnachal Pradesh791001 (Code No. ERCAPP876) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
