**ORDER**

WHEREAS, Rajkumari Sanatombi Devi College of Education, A.T. Line, North A.O.C., Imphal East, Manipur- 795001 (Code No. APE00250) was granted recognition for conducting M.Ed. course of one year duration with annual intake of 25 vide ERC's order No. ERC/7-47(ER-47.6.2)/2000/2275(1) dated 09.08.2004.

2. AND WHEREAS, Revised Recognition Order (RRO) was issued for conducting M.Ed. course of two years duration with annual intake of 50 (one basic unit) from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/ERCAPE00250/M.Ed.(Revised Order)/2015/31784 dated 20.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.


3. AND WHEREAS, a Public Notice was uploaded on ERC's website on 30.01.2018, wherein 138 TEIs have not furnished their compliance reports in respect of conditions mentioned in the Revised Recognition Orders issued on or before 31st May, 2015 on the basis of implementation of NCTE Regulations, 2014. The ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> – 17<sup>th</sup> April, 2018 considered the matter and decided, 1<sup>st</sup> Show Cause Notice was issued on 20.04.2018 to the institution on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

4. AND WHEREAS, the institution submitted reply vide letter dated 05.05.2018, received in ERC, NCTE on 11.05.2018. The ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered the matter and decided, Final Show Cause Notice was issued on 26.08.2019 to the institution on the following grounds:-

- Faculty list duly approved by concerned affiliating body is not submitted.
- Building plan is not submitted.
- Building completion certificate is not submitted.
- Website not maintained and updated.

5. **AND WHEREAS**, the institution submitted reply vide letter dated 10.08.2019 & 27.08.2019, received in ERC, NCTE on 16.08.2019 & 02.09.2019 respectively. The ERC in its 278<sup>th</sup> meeting held on 16<sup>th</sup> – 18<sup>th</sup> January, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:-

- (i) *Teaching faculty mentioned at Sl. No. 1 & 2 are Guest Professor, which is not permitted as per NCTE Regulation, 2014.*
- (ii) *Building plan (BP) is not legible.*
- (iii) *One of the FDR is less than five lakh. Hence, FDR of Rs.5 lakh & Rs.7 lakh not maintained joint as per NCTE Regulation, 2014.*

**Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.**

6. **NOW THEREFORE**, recognition granted to the institution viz. **RajkumariSanatombi Devi College of Education, A.T. Line, North A.O.C., Imphal East, Manipur- 795001 (Code No. APE00250)** for **M.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 **from the next academic session 2020-2021.**

7. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of the issue of the order.




