ORDER


WHEREAS, College of Teacher Education (B.Ed. College), Tura (Rongkhon), West Garo Hills, Meghalaya- 794002 (Code No. APE00176) was granted recognition for conducting B.Ed. course of one year duration with an intake of 60 from the academic session 1997-1998 vide ERC's order No. 3485 dated 02.05.1997. The institution was granted recognition with an additional annual intake of 40, thus making the total annual intake of 100 from the academic session 2003-2004 vide ERC's order No. ERC/7-30(ER-30.8.3(5))/2002/4354(7) dated 16.12.2002.

2. **AND WHEREAS**, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/APE00176/B.Ed.(Revised Order)/2015/31690 dated 15.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. **AND WHEREAS**, a Public Notice was uploaded on ERC's website on 30.01.2018, wherein 138 TEIs have not furnished their compliance reports in respect of conditions mentioned in the Revised Recognition Orders issued on or before 31st May, 2015 on the basis of implementation of NCTE Regulations, 2014. The ERC in its 254th meeting held on 16th – 17th April, 2018 considered the matter and decided, 1st Show Cause Notice was issued on 20.04.2018 to the institution on the following grounds:-

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.*
- Approved building plan by the concerned competent Govt. Engineer/Authority.*
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.*
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.*
- Confirmation on website updates of the institutions with all details along with affidavit.*

4. **AND WHEREAS**, the institution has failed to submit reply of Show Cause Notice within the stipulated period. The ERC in its 271st meeting held on 24th – 25th April, 2019 considered the matter and decided, Final Show Cause Notice was issued on 18.05.2019 to the institution on the grounds mentioned therein.

5. **AND WHEREAS**, the institution submitted reply vide letter dated 11.07.2019, received in ERC, NCTE on 04.02.2020. The ERC in its 280th Meeting held on 29th February 1st March, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and observed as under:-


- (i) *List of teaching faculty list is not in the NCTE prescribed proforma and not duly approved by the concerned affiliating body.*
- (ii) *Building Plan (BP) duly signed by the competent authority is not submitted.*
- (iii) *Building Completion Certificate (BCC) duly signed by the competent authority is not submitted.*

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

6. **NOW THEREFORE**, recognition granted to the institution viz. **College of Teacher Education (B.Ed. College), Tura (Rongkhon), West Garo Hills, Meghalaya- 794002 (Code No. APE00176) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.**

7. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.


