WHEREAS, Mizoram Hindi Training College, Durtlang, Vengthar, Aizawl, Mizoram-796025 (APE00252)was granted recognition for HSP (B.Ed.) course with an intake of 30 vide ERC order No. ERC/7-48(ER-48.5.7)/2004/2649 dated 09.09.2004, followed by revised recognition order from the academic session 2015-2016 with an intake of 50 (one basic unit) vide dated 31.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 254th meeting held on 16th 17th April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite
 - Approved building plan by the concerned competent Govt. Engineer/Authority.
 - Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e. Confirmation on website updates of the institutions with all details along with affidavit.
- AND WHEREAS, the institution has submitted reply dt.07.05.2018 in response to show cause notice received on 17.05.2018. The ERC in its 272ndMeeting held on 30th - 31st May & 1st June, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 18.06.2019 on the following
 - (i) The submitted faculty list comprises of 1+4 instead of 1+7 required under NCTE Regulations, 2014. Faculty list is not in accordance with NCTE prescribed proforma and not approved by affiliating body.
 - (ii) Five faculties mentioned at Sl. No. 6 to 10 of the approved list appointed on contract basis, are not accepted.
- AND WHEREAS, the institution has submitted reply dt. 08.11.2019 in response to show cause notice received on 20.11.2019. The ERC in its 278th meeting held on 16th - 18th January, 2020 after considering the matter and observed that the institution is still deficient on the following grounds:-
 - (i) Approved latest faculty list duly signed by the affiliating body has not been submitted.

(ii) Certified copy of registered land document has not been submitted.

(iii) Building Plan (BP) duly signed by the competent authority has not submitted.

(iv) Building Completion Certificate (BCC) duly signed by the competent authority has not submitted.
