ORDER

WHEREAS, Sahadev Chandravansi B.Ed. College, Vill. Nawadih Kala, P.O. Bishrampur, Dist. Palamu, Jharkhand-822 124 (APE00910) was granted recognition for B.Ed. course with an intake of 100 vide ERC's Order No. 13704 dated 06.11.2008, followed by revised recognition order vide No. 32684 dated 31.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 271st Meeting held on 24th - 25th April, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.05.2019 to the institution.

3. AND WHEREAS, the institution has submitted reply dated 24.06.2019 in response to SCN, which was considered by ERC in its 275th Meeting held on 26th July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 28.08.2019 to the institution on the following grounds:-

- (i) Information regarding change of affiliating body and its related documents i.e. NOC from the previous affiliating body along with acceptance by the present affiliating body and copy of Gazette Notification etc. are not submitted.
- (ii) Total built up area mentioned in the building completion certificate is 3125.02 sq. Mts., which is less than 4000 Sq. Mts. for running B.Ed. + D.El.Ed. course as per NCTE Regulations, 2014.
- (iii) Total land area and built up area not mentioned in the building plan.
- (iv) FDRs are not submitted.
- (v) No Mathematics lecturer appointed.
- (vi) Faculties at sl. No.8 & 15 appointed after 09.06.2017 from Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- (vii) Faculty in Sanskrit at sl. No. 13 appointed after 09.06.2017 does not possess NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.

4. AND WHEREAS, the institution has submitted reply dated 17.09.2019 received in this office on 30.09.2019. The ERC in its 279th Meeting held on 14th - 16th February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

- (i) Building Completion Certificate (BCC) is not duly signed by the competent authority.
- (ii) Building Plan (BP) is not duly approved by the competent authority.
- (iii) Website of the institution is not functional as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.




