ORDER

WHEREAS, Institute for Education, Plot No. - 1757, 1758, 1762, 1787, 1788, Street No. - Bijay 197, Vill - Bijay, Po - Seraikela, Tehsil/Taluka - Seraikela, Town/City-Bijay, Dist.-Seraikela-Kharswan, Jharkhand - 833219 (ERCAPP1405) was granted recognition for conducting B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC's order dated 03.03.2014, followed by revised order dated 25.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 274th Meeting held on 15th 16th July, 2019 considered the 2. compliance report in response to revised recognition order and as decided, Show Cause Notice u/s 17(1) was issued on 20.08.2019 to the institution.
- AND WHEREAS, the institution has submitted reply dated 06.08.2019 (on the basis of proceedings uploaded on ERC website) received in this office on 08.08.2019. The ERC in its 278th meeting held on 16th - 18th January, 2020 considered the matter and as decided, final show cause Notice u/s 17(1) was issued on 28.01.2020 to the institution on the following grounds:-
 - (i) Latest original list of teaching faculty duly approved by the affiliating body to be submitted.
 - (ii) Building Plan (BP) is not approved by the competent authority.
 - (iii) Original FDRs of Rs.5 lakh and Rs.7 lakh to be submitted.
 - (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
 - (v) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.
- AND WHEREAS, the ERC in its 279th Meeting held on 14th 16th February, 2020 considered the matter along with the reply dated 30.01.2020 from the institution in response to final show cause notice and the following observation was made:-
 - Teaching faculty mentioned at Sl. No. 1, 3, 5 & 15 are having less than required 55% marks in P.G. degree.
 - Built up area 1s less than the requirement of 4000 Sq. Mts. for running 02 units of B.Ed. and 02 units of D.El.Ed. course as per NCTE Regulation, 2014

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

AND WHEREAS, the order of withdrawal was not issued to the institution and the matter was re-considered by ERC in its 280th Meeting held on 29th February & 1st March, 2020 before confirmation of proceedings of 279th ERC meeting and observed as under:-

"Keeping in view of the total built up area, which is not sufficient to run 02 units of B.Ed. and 02 units of D.El.Ed. course as per NCTE Regulation, 2014.

Hence, the committee decided to reduce 01 unit (50 intake) from 100 intake from the next academic session i.e. 2020-21".

NOW THEREOF, recognition granted to the institution viz. Institute for Education, Plot No.- 1757, 1758, 1762, 1787, 1788, Street No - Bijay 197, Vill - Bijay, Po - Seraikela, Dist.-Seraikela-Kharswan, Town/City-Bijay, Seraikela, Tehsil/Taluka Jharkhand - 833219 (ERCAPP1405) for conducting B.Ed. Course is hereby reduced 01 unit (50 intake) from 100 intake (two basic unit) i.e. 50 intake (one basic unit) from the next academic session i.e. 2020-2021.
