- WHEREAS Radha Govind Teacher's Training College, Behind Ramgarh College, Ramgarh Cantt., Dist-Hazaribagh, Jharkhand - 829122 (APE00794) was granted recognition for M.Ed. course with an intake of 25 vide ERC Order No. 16542 dated 15/05/2009 for the session 2009-2010, followed by revised order vide No.32681dated 31/05/2015 with an annual intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- AND WHEREAS, the ERC in its 278th meeting held on 16th -18th January 2020, considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 28/01/2020 to the institution on the following grounds:-
  - (i) Original list of teaching faculty duly approved by the affiliating University has not
  - (ii) Consolidated approved Building Plan (BP) duly signed by the competent authority to be
  - (iii) Building Completion Certificate (BCC) is not in the prescribed proforma.
  - (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
  - (v) Original FDRs Rs.5 lakh and Rs.7 lakh to be submitted.
  - AND WHEREAS, the ERC in its 280th Meeting held on 29th February & 1<sup>St</sup> March, 2020, considered the matter along with the reply received from the institution on 18/02/2020 in response to Show Cause Notice dated 28/01/2020 and decided as under :-
    - There is a mismatch of built up area both Building Plan (BP) & Building Completion Certificate (BCC). Photocopy of Building Plan (BP) is in piecemeal and not (i) approved by competent authority.
    - Photocopy of Building Plan (BP) is in piecemeal and not approved by competent (ii) authority.

Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

NOW THEREFORE, recognition granted to the institution viz. Radha Govind Teacher's Training College, Behind Ramgarh College, Ramgarh Cantt., Dist-Hazaribagh, Jharkhand - 829122 (Code No. APE00794) for M.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the 1. Mysh I academic session 2020-2021.
