ORDER

WHEREAS, ICFAI College of Education, Agartala, ICFAI University, Bidurkartaa Chowmohani, Jagannath Bari Road, Agaratala, Tripura – 799001 was granted recognition for B.Ed. Course with an intake of 100 from the academic session 1977-78 vide ERC Order No. ERC/7-62.5.3/2005/1449 dated 23.11.2005 followed by revised recognition order No. 32426 dt. 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered the matter in its meetings held time to time observed as under:

1st show cause notice u/s 17(1) issued on 14.02.2019, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following grounds:-


(i) Building Completion Certificate is not signed by Govt. Engineer.

Recognition granted to B.Ed. course is withdrawn under section 17(1) was issued vide order No. 61344 dated 22.08.2019 to the institution and all concerned.

3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 22.08.2019. The Appellate Authority vide its Order No. 89-395/E-137429/2019 Appeal/35th Mtg.-2019/25th November, 2019/86040 dated 13.12.2019 remanded back the case to ERC with a direction to consider the Building Completion Certificate to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the Building Completion Certificate submitted in appeal, in original, if necessary, within 15 days of receipt of orders on the appeal.

4. **AND WHEREAS**, the ERC in its 279th meeting held on 14th -16th February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 13.12.2019, were carefully considered by ERC and decided as under :-


Restoration of recognition order of B.Ed. course to be issued.


