<u>ORDER</u>

In terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to El- Bethel College, At /Po- Rasapunja, P.S- Bishnupur, Kolkatta, Distt- South 24 Parganas, State- West Bengal-700104 for B.Ed. course of one year duration with an intake of 100 students vide ERC Order No. ERC/7-83.13.2/2008/102100 dated 26 /28 .02.2008 followed by revised recognition order for B.Ed. course of two years duration with an intake of 100 students (two basic units) from the academic session 2015-2016 vide order No.F.ERC/APE00809/B.Ed/(Revised Order)/2015/32367 dated 29.05.2015.

2. **AND WHEREAS**, the said recognition was withdrawn under section 17 of NCTE Act, 1993 vide order F. No. ER-284.18/ APE00809 /B.Ed /2020 /63077 dated 29.09.2020.

3. AND WHEREAS, the institution had filed an appeal before the Council (NCTE) under section 18 of NCTE Act, 1993 against the withdrawal order dated 29.09.2019. The Appellant Authority passed an order dated 04.10.2021 and confirmed the withdrawal order passed by ERC.

4. Aggrieved by the withdrawal order the institution filled W.P.A. 15631 of 2022 before the Hon'ble High Court of Calcutta. The Hon'ble Court passed an order dated 17.08.2022. In compliance of order dated 17/08/2022 passed by the Hon'ble High Court of Calcutta in W.P.A. 15631 of 2022, the mater was placed before ERC in its 309th meeting held on 14.09.2022 and the committee decided as under:

"In compliance of the Court Order dated 09.09.2022 passed by the Hon'ble High Court of Calcutta in W.P.A. 15631 of 2022, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

- Recognition of institution for running B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session 2021-22 vide Order dated 29.09.2020 which was also confirmed by the Appeal Committee vide its Order No. Appeal order No. F. No. 89-218/E-192496/2021 Appeal/20th Mtg.-2021 dated 04.10.2021.
- Being aggrieved, the institution filed W.P.A. 15631 of 2022 before the Hon'ble High Court of Calcutta and the Hon'ble passed an Order dated 09.09.2022.
- In compliance of the directions passed by the Hon'ble High Court of Calcutta in W.P.A. 15631 of 2022, the representative namely Mr. Kazinajiboor Rahman submitted certain documents in ERC office on 13.09.2022 with regard to compliance of deficiencies.

In compliance of the Court Order dated 09.09.2022 passed by the Hon'ble High Court of Calcutta in W.P.A. 15631 of 2022, the documents submitted by the representative of the institution in ERC Office were considered carefully by ERC and the Committee decided to restore the recognition for B.Ed. programme granted to institution vide recognition order No. ERC/7-83.13.2/2008/102100 dated 28.02.2008.

5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. El- Bethel College, At /Po- Rasapunja, P.S- Bishnupur, Kolkatta, Distt- South 24 Parganas, State- West Bengal-700104 vide order No.F.ERC/APE00809/B.Ed/(Revised Order)/2015/3236 dated 29.05.2015 for B.Ed. course is hereby restored.
