## **ORDER**

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to SRP Teachers Training College, Plot No.-221, Street No.-Reyannagar, Vill.- Madhopara, P.O.- Purnea, Tehsil/Taluka- Purnea, Town/City-Purnea, Dist.- Purnea, Bihar-854301 for B.Ed. course of two year duration with an intake of 100 vide ER-248.6.16/ERCAPP3275/B.Ed./2018/55822 dated 31.01.2018.

- 2. AND WHEREAS, as per decision taken by ERC in its 284<sup>th</sup> meeting held on 17<sup>th</sup> to 18<sup>th</sup> Sep, 2022, Show Cause Notice was issued to the institution under Section 17(1) of NCTE Act, 1993. The reply submitted by the institution was considered by ERC in its 304<sup>th</sup> meeting and final Show Cause Notice was issued on 21.04.2022. The institution had submitted its reply against Show Cause Notice vide letter dated 21.04.2022.
- 3. AND WHEREAS, the institution filed Writ Petition No. 10890/2021 before the Hon'ble High Court of Judicature at Patna, which was disposed of vide order dated 18.05.2022. The operative part of order is as under:-
  - "...The institution has submitted their reply on 09<sup>th</sup> May, 2022 and have removed all the deficiencies as pointed out by the E.R.C. of N.C.T.E. in its meeting dated 11<sup>th</sup> April, 2022.

Learned counsel submits that directions may be issued to E.R.C. to finally decide the matter after the final show cause notice.

Keeping in view aforesaid statement made by the learned counsel at Bar, it is expected that the E.R.C. shall consider and examine the case of the petitioner and also take into consideration the letter dated 9<sup>th</sup> May, 2022 submitted by the Institute with regard to removing of the deficiencies as pointed out by the E.R.C. earlier.

The E.R.C. shall pass fresh orders with regard to counselling and admissions for the subsequent Session namely 2022-2023...."

**4. AND WHEREAS,** in compliance of above order dated 18.05.2022, the matter was considered by ERC in its 308<sup>th</sup> meeting held on 02<sup>nd</sup> Sep, 2022 and decided that an Order for continuation of recognition granted to SRP Teachers Training College, Plot No.-221, Street No.- Reyannagar, Vill.- Madhopara, P.O.- Purnea, Tehsil/Taluka-Purnea, Town/City-Purnea, Dist.- Purnea, Bihar-854301 for B.Ed. programme for 100 seats (2 basic units of 50 students each) be issued. The institution is entitled for counselling and take admission from the academic session 2022-2023 onwards.
