Sub: Conveying the decision taken by ERC in its 307th(Virtual) meeting held on 05th Aug, 2022 in respect of institution viz. Ram Baran Roy B.Ed College, Plot No. 27, Street Number Main Road, Village – Shyampur Bairo (Main Bairo) Post- Hansi ewal, Tehsil/ Taluka- Bhagwanpur. Town/City- Bhagwanpur, Distt- Vaishali, Bihar -844131 (Code No. ERCAPP853) (B.Ed.) - reg.

Sir/Madam.

In terms of decision taken by ERC in its 303th (Virtual) meeting, held on 24th March, 2022, the Final Show Cause Notice was issued to Ram Baran Roy B.Ed, College, Plot No. 27, Street Number Main Road, Village – Shyampur Bairo (Main Bairo) Post- Hansi Kewal, Tehsil/ Taluka- Bhagwanpur Town/City- Bhagwanpur, Distt- Vaishali Bihar -844131 for B.Ed. course vide letter dated 06.04.2022.

- 2. The institution had filed a Writ Petition No. 11281/2022 before the Hon'ble High Court of Delhi against the Show Cause Notice issued by ERC letter dated 06.04.2022. The Hon'ble High Court passed an order dated 29.07.2022. The operative part of order is as under:
 - a. The ERC shall issue a corrigendum to the restoration order dated 31st January, 2022 clarifying that the restoration of recognition to Petitioner-institute for B.Ed course shall not be limited up to the end of academic session 2021-2022, but shall also be extended to academic session 2022-2023 and all other subsequent academic sessions until a withdrawal order is passed against Petitioner-institute.
 - b. Petitioner-institute shall now be permitted to participate in the counselling and admit students for the year 2022-23 and also for subsequent years until a withdrawal order is passed against it, which would be given effect to in terms of proviso to Section 17 of the National Council for Teacher Education Act, 1993.
 - c. The status of Petitioner-institute shall be reflected as a recognised institution on Respondents' website, and Respondents shall intimate the same to Petitioner-institute's affiliating university as well as to the concerned departments of the respective State Government

In the light of above directions passed by the Hon'ble High Court, the case was considered by ERC-NCTE in its 307th (virtual) meeting, held on 05th Aug, 2022, and the Committee decided that in compliance of direction passed by Hon'ble High Court of Delhi vide its order dated 29.07.2022, corrigendum be issue to institution for restoration order dated 31st January, 2022 clarifying that the restoration of recognition to Petitioner-institute for B.Ed course shall not be limited up to the end of academic session 2021-2022, but shall also be extended to academic session 2022- 2023 and all other subsequent academic sessions until a withdrawal order is passed against Petitioner-institute. Further ERC decided that the institution is entitled to participate in the counselling and admit students for the year 2022-23 and also for subsequent years until a withdrawal order is passed against it. The status of institute shall be reflected as a recognised institution on ERC website, and ERC shall intimate the same to Petitioner-institute's affiliating university as well as to the concerned departments of the respective State Government'.
- 4. In terms of above decision, it is hereby clarified that the restoration order dated 31.01.2022 for B.Ed course shall not be limited up to the end of academic session 2021-2022, but shall also be extended to academic session 2022-2023 and all other subsequent academic sessions until a withdrawal order is passed against Petitioner-institute. Further it is also clarified that the institution is entitled to participate in the counselling and admit students for the year 2022-23 and also for subsequent years until a withdrawal order is passed against it.
