WHEREAS, Sri Ramakrishna Sarada Ashrama Teacher's Training College, Plot No. 1666, 1671, 1670, 1672, 1698, 1700, At/Po- Hazaribagh, Dist- Hazaribagh, Jharkhand — 825301 (Code No. ERCAPP48) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order 22.07.2012, followed by revised order vide No. 32707 dated 31.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 279^{th} held on $14^{th} 16^{th}$ February, 2020 considered the matter and as decided, final show cause notice u/s 17(1) of NCTE Act, 1993. Accordingly final show cause notice was issued on 06.03.2020 to the institution on the following grounds:
 - (i) Faculty list duly approved by the concerned affiliating body in the NCTE prescribed proforma not submitted.
 - (ii) Total built up area mentioned in the building completion certificate is 37306.31 Sq. ft. Or 3465.86 Sq. Mts. which is less than the required 4000 Sq. Mts. for existing B.Ed. (100 intake) + D.El.Ed. (100 intake) as per NCTE Regulations, 2014.
 - (iii) Total built up area mentioned in the building completion certificate mismatch with the submitted two building plans. Further, one building plan based on two plots (1699 & 1702) is added whereas the land deed along with related documents not submitted.
 - (iv) Converted FDRs in joint operation mode is required to be uploaded on institution website.
 - (v) Certificate copy of registered land document to be submitted.
 - (vi) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- 3. AND WHEREAS, the ERC in its 284th meeting held on 17th 18th September, 2020, considered the matter along with the reply dated 02.03.2020 received in this office on 05.03.2020 submitted by the institution in response to Final Show Cause Notice and observed as under:
 - a) Sampati Paul possesses 52% marks in Master Degree, which is not permissible as per Regulation, 2014.
 - b) Soma Sarkar possesses 50% marks in Master Degree, which is not permissible as per Regulation, 2014.
 - c) There is mismatch between Building Plan (BP) and Building Completion Certificate (BCC). However, latest Building Plan (BP) is not submitted.
 - d) Original FDRs Rs.5 lakh and Rs.7 lakh is not submitted.
 - e) Certified copy of registered land document is not submitted.
 - f) Validity of Fire Safety Certificate has been expired on 18.11.2019.

In view of the above, the Committee decided as under:

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.

Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2021-2022.
- 5. FURTHER, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
