WHEREAS, Mizoram Hindi Training College, Durtlang, Vengthar, Aizaw!, Mizoram-796025 was granted recognition for HSP (B.Ed.) Course with an intake of 30 vide ERC Order No. ERC/7-48(ER-48.5.7)/2004/2649 dated 09.09.2004 from the academic session 2004-2005, followed by revised recognition order No. 32641 dt. 31.05.2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 278th meeting held on 16th 18th January, 2020 considered the matter and as decided, recognition granted to HSP(B.Ed.) course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-278.58/APE00252/HSP(B.Ed.)/2020/62153 dated 28.01.2020 from the academic session 2020-2021 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 28.01.2020. The Appellate Authority vide its Order No. 89-102/E-158223/2020 Appeal/22nd Mtg.-2020/9th October, 2020/94493 dated 19.10.2020 decided that Appeal Section should detach the originals of these documents from Appeal file and forward to ERC. Appeal Committee further decided to remand back the case to ERC for revisiting the case.
- 4. AND WHEREAS, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 19.10.2020 and the committee decided as under:-

Restoration of recognition order of B.Ed. (Hindi Shiksha Parangat (HSP)) course with an annual intake of 50 students (01 unit) be issued.

- 5. NOW THEREFORE, recognition withdrawn vide order dated 28.01.2020 to the institution viz. Mizoram Hindi Training College, Durtlang, Vengthar, Aizawl, Mizoram-796025 for B.Ed. (Hindi Shiksha Parangat (HSP)) course is hereby restored recognition with an annual intake of 50 students (01 unit).
- 6. The terms and conditions of the order F. ERC/NCTE/APE00252/Hindi Shikshan Parangat (HSP).(Revised Order)/2015/32641 dt. 31.05.2015 issued to the institution shall remain same.
