WHEREAS, Scottish Church College, 1 & 3, Urquhart Square, Beadon Street, Kolkata, West Bengal - 700 006 (APE00245) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2004-2005 vide ERC order dated 02.11.2004, followed by revised recognition order issued on 29.05.2015 with an intake of 50 (one basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHERAS,** the ERC in its 278<sup>th</sup> meeting held on  $16^{th} - 18^{th}$  January, 2020 considered the matter and decided to withdraw recognition granted to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021 to the institution. Accordingly, withdrawal order was issued vide order No. F.No.ER-278.74/APE00245/B.Ed./2020/62254 dated 05.02.2020 to the institution.

3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 05.02.2020. The Appellate Authority vide order No.89-64/E-155538/2020 Appeal/12<sup>th</sup> Mtg.-2020/24<sup>th</sup> July, 2020/93064 dated 15/09/2020 decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

4. **AND WHEREAS**, the institution submitted representation dated 23.09.2020 received in this office on 29.09.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.09.2020, were carefully considered by ERC in 286<sup>th</sup> meeting held on  $25^{th} - 26^{th}$  November, 2020 and the Committee decided as under:-

"Restoration of Recognition Order of B.Ed. course with an annual intake of 50 students (01 unit) to be issued".

5. NOW, THEREFORE, recognition withdrawn vide order no. F.No.ER-278.74/APE00245/B.Ed./2020/62254 dated 05.02.2020 to the institution viz. Scottish Church College, 1 & 3, Urquhart Square, Beadon Street, Kolkata, West Bengal - 700006 (Code No. APE00245) for B.Ed. Course is hereby restored recognition with an annual intake of 50 students (01 unit).
