ORDER

WHEREAS, Govt. Hindi Teachers' Training College, Imphal, Manipur-795001 was granted recognition for HSP (B.Ed.) Course with an intake of 60 from the academic session 1997-1998 vide ERC's order dt. 11.02.1997. The intake has been enhanced from 60 to 100 from the academic session 2006-2007 vide ERC's order dated 04.01.2006, followed by revised order vide No. 31794 dated 20.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 198th meeting held on 20th -21st Nov, 2015 considered the representation dated 30.07.2017 from Director, University and Higher Education Govt. of Manipur and as decided, a letter vide No. 39507 dt. 04.12.2015 was issued to the institution with reducing intake of B.Ed. Course from two basic units to one basic unit i.e. 50 intake from the academic session 2016-2017.
- 3. AND WHEREAS, the ERC in its 274^{th} meeting held on $15^{th} 16^{th}$ July, 2019 considered the matter in its meetings held time to time observed as under:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e. Confirmation on website updates of the institutions with all details along with affidavit.

No reply received and the stipulated time period has already been over.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

- 4. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 16.09.2019. The Appellate Authority vide its Order No. 89-103/2020 Appeal/15th Mtg.-2020/29th July, 2020/93192 dated 15.09.2020 decided that appellant institution/ University is required to submit within 15 days of the issued of appeal orders to ERC all the required documents particularly the building completion certificate clearly indicating the built up area earmarked for the applicable course. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.
- 5. **AND WHEREAS**, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 15.09.2020, and decided as under:-

- 6. **NOW THEREFORE**, recognition withdrawn vide order dated 03.03.2020 to the institution viz. **Govt. Hindi Teachers' Training College, Imphal, Manipur-795001** for B.Ed. (Hindi Shiksha Parangat(HSP)) course is hereby restored.
- 7. The terms and conditions of the order No. F. ERC/7-198.12.1/ERCAPE00306/B.Ed./2015/39507 dt. 04.12.2015 issued to the institution shall remain same.
