WHEREAS, College of Teacher Education (B.Ed. College), Tura (Rongkhon), West Garo Hills, Meghalaya-794002 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No. ERC/7-30(ER-30.8.3(5)/2002/4354(7) dated 16.12.2002 from the academic session 2003-2004, followed by revised recognition order No. 31690 dt. 15.05.2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February 1<sup>st</sup> March, 2020 considered the matter in its meetings held time to time observed as under:
  - (i) List of teaching faculty list is not in the NCTE prescribed proforma and not duly approved by the concerned affiliating body.
  - (ii) Building plan (BP) duly signed by the competent authority is not submitted.
  - (iii) Building Completion Certificate (BCC) duly signed by the competent authority is not submitted.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

- 3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 03.03.2020. The Appellate Authority vide its Order No. 89-164/E-162751/2020 Appeal/22<sup>nd</sup> Mtg.-2020/9<sup>th</sup> October, 2020/94505 dated 19.10.2020 decided that appellant institution is required to submit within 15 days of the issued of appeal orders complete list of faculty and B.C.C. in original to ERC. Appeal Committee decided to remand back the case to ERC for revisiting the matter. Appellant institution is required to submit to ERC within 15 days of the issue of appeal orders (i) complete list of faculty, (ii) Building Plan and Building Completion Certificate indicating the built up area.
- 4. **AND WHEREAS**, the ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 19.10.2020, and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 50 students (01 unit) to be issued.

- 5. NOW THEREFORE, recognition withdrawn vide order dated 03.03.2020 to the institution viz. College of Teacher Education (B.Ed. College), Tura (Rongkhon), West Garo Hills, Meghalaya-794002 for B.Ed. course is hereby restored.
- 6. The terms and conditions of the order No. F. ERC/NCTE/APE00176/B.Ed. (Revised Order)/2015/31690 dt. 15.05.2015 issued to the institution shall remain same.
