ORDER

WHEREAS, Regional College of Physical Education, Panisagar North Tripura, Tripura-799260 was granted recognition for B.P.Ed. Course with an intake of 60 vide ERC Order No. ERC/7-18/2001/1525 dated 28.05.2001 from the academic session 2001-2002, followed by revised recognition order No. 32650 dt. 31.05.2015 with an intake of 100 (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 275th meeting held on 27th July, 2019 considered the matter and as decided, recognition granted to B.P.Ed. course was withdrawn u/s 17(1) of NCTE Act, 1993 vide order No.ER-282.25/(TR-SO/N-1/2000)/B.P.Ed./2020/62800 dated 16.07.2020 from the academic session 2021-2022 to the institution.

3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 16.07.2020. The Appellate Authority vide its Order No. 89-157/E-162136/2020 Appeal/22nd Mtg.-2020/9th October, 2020/94501 dated 19.10.2020 decided that appellant institution is required to submit the original of the list to ERC within 15 days of the issue of appeal order. Appeal Committee further decided to remand back the case to ERC for revisiting the matter.

4. AND WHEREAS, the ERC in its 286th meeting held on 25th & 26th November, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 19.10.2020 and the committee decided as under :-

Restoration of recognition order of B.P.Ed. course with an annual intake of 100 students (01 unit) to be issued.

5. **NOW THEREFORE**, recognition withdrawn vide order dated 05.02.2020 to the institution viz. **Regional College of Physical Education, Panisagar North Tripura, Tripura-799260** for **B.P.Ed.** course is hereby **restored recognition with an annual intake of 100 students (01 unit)**.

6. The terms and conditions of the order F. ERC/NCTE/(TR-SO/N-1/2000)/B.P.Ed./(Revised Order)/2015/32650 dt. 31.05.2015 issued to the institution shall remain same.
